










Brewster County COVID-19 Dashboard



Gas Utility Update - DIMP

The gas department DIMP Plan has changed as of January 6th 2020 to reflect 10% replacement of steel services in Zone 2 in both Alpine and Fort Davis.

This consists in replacing 42 services in Alpine and 14 services in Fort Davis.

With Covid-19 causing some changes in operations and the replacement of main and services behind the Holland Hotel we pushed the Leak Survey Out four months.

- Grade 3 leaks totaling 37 between Alpine and Fort Davis, all but 7 remain un-repaired in Alpine and we are currently working on them, which will help bring down the numbers of DIMP services that need to be replaced.
- Leak survey consisted of a total of 126 leaks, 72 above ground leaks between Alpine and Fort Davis (all repaired), and 54 below ground leaks between Alpine and Fort Davis (17 were Grade 1 & 2 Leaks all Repaired).

To date the gas department has not had a Railroad Commission Audit nor a TML Audit this year

To date is as followed for DIMP

Alpine-Zone 2: 25 of 42 have been replaced leaving 17 left for the year.

Fort Davis-Zone 2: 14 left for the year.

Totals to be completed for the year: 31 services.

Leaks

Above Ground Leaks Repaired

- 65 above ground leaks in Alpine
- 7 in Fort Davis

Grade 1 & 2 below ground leaks Repaired

- 13 in Alpine
- 6 in Fort Davis

Grade 3 below ground leaks Repaired

- 20 of the 27 grade 3 below ground leaks in Alpine
- 11 of 11 in Fort Davis





Water/Wastewater Utility


June & July have proven to be very productive for water utilities team members. We are currently working on a number of projects related to our SCADA operating system and water treatment plant upgrades. These projects are scheduled for completion between August – September 2020. Department operations data is as follows:

SCADA: in motion to move forward with replacing our SCADA operating system that monitors and controls the city water supply system. The current system is in such poor condition that we have been operating entirely in "manual" mode – which translates to hand operating the system with manual control switches, around the clock.

- Project Manager Shane Evans has been working to harvest all of the old antennas and other components from the old system, in an effort to save money on parts cost, and has accumulated approx. \$12,000 in savings by performing complex work in-house in lieu of contractors.
- $^{\circ}$ Mr. Evans has also taken a lead role in designing & erecting 11 40' radio towers at all well sites to accommodate communications for the new SCADA system.

Training

Operator Training – DPU Scott Perry and Project Manager Shane Evans are hosting training sessions for all Water & WW personnel that include topics such as TCEQ Rules & Regulations, equipment orientation & training for basic water sampling procedures, Algebra & Geometry for water utilities (Volume, lift, GPM measurements, etc.) The sessions are completely interactive and hands-on. All participants complete worksheets from the training sessions that can be used for reference by personnel in their daily duties. Staff members are not graded on their work – it is the engagement that we all benefit from as we learn together.

WASTEWATER TREATMENT PLANT

Task Order #3 – J&M Engineering has been issued a task order by the city to follow up on the failed aerator replacement project that was started by another firm in 2018. The order includes comprehensive spec, design and management of aerator replacement and installation, as well as the installation of the automated bar screen.

WWTP Main Breaker Panel/ Replacement – The main breaker panel located at the lift-station at the head of the plant. This panel is critical for the proper function of the entire WWTP, as it moderates the proper consistent flow into the plant. *Installation of the automated bar screen was put on hold due to the breaker panel's degraded condition. Installation is moving forward at this time.

Sludge Removal/Belt Press – The belt press unit that the city had agreed to purchase approx. 12 months ago has been in operation since January 2020. During the 7 months of operation, city staff have struggled to keep the machine from experiencing minor technical issues, resulting in shut down of operation. WWTP staff have worked diligently with Skinner's Well Service to replace worn components & get the machine operating properly. I am happy to report that the belt press unit is now in perfect working order & generating sludge at a much higher rate that before. We are currently scheduled to waste sludge 5 a week.

William Drake II/ PT Operator – Mr. Bill Drake is a Double AA Licensed Water/Wastewater Operator that has come to work part time with the city as a mentor and advisor to assist the city with maintain compliance with TCEQ @ approx. 8 hours per week. Bill retired from the City of Abilene as Wastewater Director and also assist several other cities in west Texas ion an advisory capacity.

AIRPORT OPERATIONS

Business has been slow, but consistent for the Alpine airport during recent months. Fuel sales are down slightly to date. This is mostly attributed to the reduction in travel due to Covid 19, as well as reduced flying hours by CBP and TxDPS due to various conditions. CBP has transferred the Huey Helicopter that was based here to El Paso which will also result in a reduction in air traffic for now. Other highlights are as follows:

The position of Airport Supervisor has been posted and is currently open for applications.

ACMA/TxDot lighting project – Representatives from Lochner Aviation and TxDot were out during the month of July to perform inspections from previous work performed & gather information to move forward with the current lighting project. More information to follow next month.


