



Covid Safety Policies

GA-34 went into effect on March 10, 2021

- Opened businesses to 100% Occupancy unless Affidavit signed by County Judge
- Lifted Mask Requirement
- Allowed businesses to maintain their own policies for Health, Safety and PPE

City Offices Kept Previous Precautionary Measures in Place (Primarily)

- City Hall: Opened lobby (change) to three occupants, still have option of outside window or dropbox
- Animal Shelter: Staff lets Visitor's in when they arrive, no appointment necessary, but encouraged
- Visitor Center: Lobby is open for up to five occupants, full assortment of materials on porch
- Mask required in the City facilities

Hosted call with Hoteliers and STR businesses walking through new Executive Order and their options: several will keep the same protocol they have been using

Goal is to pursue support of businesses to operate in a fashion they feel comfortable with

West Texas Gas Update



In October of last year, the Pipeline and Hazardous Materials Safety Administration (PHMSA) amended the existing federal Pipeline Safety Standard (49 CFR Parts 192) for gas transmission and gathering pipelines. This new set of regulations is referred to as the “Gas Mega Rule”.

Met with West Texas Gas last week to discuss solutions on moving the ‘City Gate’ locations in both Alpine and Ft. Davis to allow for the classification of some existing infrastructure to revert back to Class 1 instead of Class 3

- City of Alpine would also pick up some additional infrastructure in the process

These changes would mitigate the need for some of the Testing requirements in the ‘Mega Rule’ – the testing can create prolonged outages

Opens up opportunity for selling of Natural Gas in Sunny Glenn

Proposed changes to come before Council in late April or May 2021

Status of FY2019-2020 Financial Audit

State Requires filing by March 31st of each year

- We've contacted them that we will be late this year
- Working to get our Grants notified as well
- Will utilize our draft form of the audit for our creditors (relative to debt payments)

Q2 Difference

- **Code Compliance Process**

1. Report of possible violation received.
2. Property is scheduled for inspection.
3. If violation exists, the violator is notified first by personal contact and/or a letter giving a period of time to correct the violation.
4. Property is re-inspected at expiration of time period.
5. If violation has not been corrected, a Notice of Civil Violation may be issued. Failure to correct a violation may be subject to fines.
6. When violation has been resolved, case is closed.
7. Major violations such as demolition of a home, building, mobile home, work without permits hazardous waste, such as tires, batteries, or oil spills a stop work order will be issued along with a fine. The Code Compliance Officer will explain the abatement process with the offender.




