

Drought Contingency – Mild Conditions

- Trigger Condition for Mild Conditions Drought Contingency –
 - Water demand reaches ninety percent (90%) of firm production capacity;
 - Disruption due to equipment or distribution system failure that would limit the capacity of the water system below eighty-five (85%) of capacity during high demand periods.
- Measures
 - Public shall be informed, by local news media, that a trigger condition has been reached and they should look for ways to voluntarily reduce water demand.
 - There shall be reduced watering of public parks, public facilities and esplanades to minimum levels to avoid loss of vegetation.

Drought Contingency – Mild Conditions

- Measures Continued

- Voluntary lawn-watering schedule
 - Customers with even numbers street addresses should water lawns on even-numbered days early in the morning, or late in the evening.
 - Customers with odd-numbered street addresses should water lawns on odd-numbered days early in the morning, or late in the evening.

- Measures Continued

- Request voluntary water reductions of major commercial water users.
- City will continue to monitor water demand. If drought conditions persist or conditions worsen, further conservation measures will be implemented including mandatory water rationing.
