

SUBJECT: Terminating Vistas

The Public Arts Board has been directed to examine possible ways to enhance the City's Terminating Vistas through the use of public art. Birmingham's Downtown Overlay Plan identifies multiple intersections as Terminating Vistas where Section 3.04(E)(15) states:

Any building that terminates a view, as designated on the Regulating Plan, shall provide distinct and prominent architectural features of enhanced character and visibility, which reflect the importance of the building's location and create a positive visual landmark.

Photos of Terminating Vistas are provided below. As of now, an electrical box has been painted as a popcorn box at S. Old Woodward and Merrill, while it has been recommended that the electrical box at Oakland and N. Old Woodward be painted as a crayon box while the box on Merrill in front of Chase Bank be painted as a Game Boy. Meanwhile, the Terminating Vista site at S. Old Woodward and Woodward has a vacant sculpture pad since Mark DiSuvero's Choopy was removed in July of 2019. It is also of note that the intersections with designated Terminating Vistas of Willits and and N. Old Woodward has the sculpture *Torso* by Herb Babcock, and *LOL* by Kirk Newman is placed at Maple and Peabody.





SUBJECT: Electric Box Paintings


On May 22, 2019, The City Commission approved the Public Arts Board recommendation to paint the electric box in front of Birmingham 8 Theater as a popcorn box. Upon approval, the City Commission recommended examining designs for the other electrical boxes located in downtown Birmingham. Please see attachments for photos of current Popcorn Box painting, as well as the electrical boxes location along Old Woodward Avenue at Merrill Street and Oakland Street.

On August 21st, 2019, the Public Arts Board considered these electrical boxes and discussed whether or not to try to keep the boxes contextual with their surroundings. It was determined that these tenants and nearby spaces were less of a fixture in Birmingham's downtown, therefore the concept should not necessarily be related to its surrounding.

There was consensus that the Board wanted a style that was thematic with pop art. The Board liked the ideas for a crayon box at N. Old Woodward and Hamilton, and an 80's retro style mixed-tape cassette for the electrical box in front of Chase Bank. Anne Ritchie was nominated to paint create and paint these designs.

Anne Ritchie brought up the USB charging stations located throughout downtown beside the new benches, and how a number of people were mistaking them for ash trays. Anne suggested painting some type of electrical themed design on these charging stations as well. There was general consensus from the Board that this was a great idea.


On September 18th, Anne Ritchie provided her renderings for the Crayon Box, which was approved by the Board. Anne Ritchie also expressed her opinion that the box in front of Chase Bank was too wide to paint, and perhaps the Board should pursue other ideas. Concepts such as a Walkman and a Game Boy with Tetris on the Screen were brought up. There was general consensus that the Board liked the idea of a Game Boy with Tetris, and would like to see renderings at the next meeting.


