## **Final Selection**

They will forward a recommendation of the top 2 or 3 candidates to the Retirement Board and Retiree Health Care Fund Investment Committee at their regular meetings on June 11, 2021.

The Retirement Board and Retiree Health Care Fund Investment Committee may then choose to accept the Committee's recommendation and appoint the investment consultant during those meetings. Or, they may choose to schedule a special meeting(s) to interview some or all of the applicants before making a decision.

We will notify you of any actions taken during the June 11 meetings related to the investment consultant proposals.
