Agenda item #1: Request for Two Art Donation Installations:

a. Helen Hierta - "Weathered" - Art on Loan Application

CP Cowan presented to the Parks and Recreation Board Artist Helen Hierta sculpture "Weathered" as part of the City of Birmingham Public Arts Board's 2021 Call For Entry.

CP Cowan stated that the Public Arts Board (PAB) reviewed the application and felt the best locations for such items would be near the entrance of the City's park trails. The Board felt that the remaining location in the Call-for-Entry were not quite suitable for the subject sculptures given the size and scale. The sculpture is a meditation pole consisting of ceramic material that stands 8' tall, 20" wide, and attaches to the ground with an interior stability pole.

CP Cowan stated according to the artist, "Weathered" is intended to encourage a meditation on the vast unseen human energy fields – a whole network of intelligence glistening under the surface of things – and their complex vibrations that radiate all around us.

CP Cowan stated the PAB felt that "Weathered" is a tranquil, natural piece of art that also goes well as a marker for an entrance to a nature trail. The PAB moved to recommend approval for the sculpture loan of "Weathered" by Helen Hierta for the proposed location at the intersection of Linden Trail and W. Lincoln the sculpture would be on loan for three (3) years.

It was moved by Noble, seconded by Collins to move to recommend approval of the application for the sculpture on loan titled "Weathered" by Helen Hierta to be located at the intersection of Fairway Trail and W. Lincoln Street.

b. Ray Katz "Astral Projection" – Art on Loan Application

CP Cowan presented to the Parks and Recreation Board Artist Ray Katz sculpture "Astral Projection" as part of the City of Birmingham Public Arts Board's 2021 Call For Entry.

CP Cowan stated the Public Arts Board reviewed renderings of "Astral Projection" at the proposed location of Crestview Park near the corner of Southlawn and Southfield. The PAB liked the variety of colors, shapes, and height that "Astral Projection" would bring to the area. The PAB also preferred the one base pad that would be required for installation and would be more ideal for a sculpture on loan.

CP Cowan stated that PAB moved to recommend approval of the sculpture on loan titled "Astral Projection" by Ray Katz to be located at Crestview Park near the corner of Southfield and Southlawn. PAB moved to recommend approval of the sculpture on loan titled "Astral Projection" by Ray Katz to be located at Crestview Park near the corner of Southfield and Southlawn and would be on loan for three (3) years.

Collins stated that Crestview Park is being reviewed for potential pickleball.

CP Cowan stated that he has been in discussion with PM Laird on the proposed location at Crestview Park.

PM Laird stated that there would be room for the artwork to be placed at the corner pf Crestview Park as CP Cowan showed and would not interfere with potential pickleball.

Kaplan asked about what type of pad the artwork would be placed on. CP Cowan stated that the pad installation would be coordinated with the engineering sidewalk program that takes place in the spring/summer. CP Cowan stated that the pad could be tailored to the artwork.

Graham asked if the artwork being installed at Fairway Trail and W. Lincoln Street would have a pas as well. CP Cowan stated that the artist has requested no pad for this artwork.

Carmona stated she does not want to question the placement of "Astral Projection" by the PAB but in terms of the potential pickelball location at Crestview Park would it be considered an abstraction. It was moved by Lipp, seconded by Noble to postpone the consideration of the application for the sculpture on loan titled "Astral Projection" by Ray Katz to be located at Crestview Park near the corner of Southfield and Southlawn until the PAB coordinates with city staff with the installation of the pickleball courts.

COMMUNICATION/DISCUSSION ITEM #1: Pickleball 2.0

PM Laird presented to the Parks and Recreation Board the five (5) potential pickleball locations that were: Crestview Park, Kenning Park, Poppleton Park, St. James Park and West Lincoln Well Park.

PM Laird stated that in staff began exploring various options for pickleball locations and presented 5 potential locations at the May 11, 2021 Parks and Recreation Board Meeting. Additionally, the locations were posted to Engage Birmingham as a survey, asking residents to rank the locations, with 1 being their favorite and also to let us know the reason for their #1 choice. The five locations, and results of this first survey were:

Kenning Park (NE Corner of Lincoln and Eton):#1

St. James Park: #2
Poppleton Park: #3
W. Lincoln Woll Park:

W. Lincoln Well Park: #4

Crestview Park: #5

PM Laird stated that the city engaged the services of Foresite Design, a local architect with a unique and primary focus in the design and implementation of athletic and recreational facilities, beginning with site assessments and potential designs for each of the 5 locations.

PM Laird stated that considerations throughout this process included, but are not limited to the number of pickleball courts to offer, site amenities, parking, current uses of the park, future planned projects, proximity to nearby residents, and ADA accessibility.

Goals were set to provide at least 6-8 pickleball courts at each location, have adequate parking available, and to maintain existing park fields, playground and court areas. From the five (5) locations to three (3) – Kenning Park, St. James Park, and Crestview Park based upon listed criteria above.

PM Laird shared with the Parks and Recreation Board members potential pickleball courts overlays on current park photos.

PM Laird shared with the Parks and Recreation Board members the number of tennis reservations through the recreation program which totaled 3,558 for the 2021 tennis season from January 1, 2021 through November 8, 2021.

PM Laird stated there would be a survey placed on Engage Birmingham from November 15, 2021 through November 30, 2021 and at the December 7, 2021 Parks and Recreation Board meeting there will be a recommendation for pickleball courts.

PM Laird stated that screening and fencing would be installed around the pickleball courts.

Carmona would have to physically leave the room until the discussion is completed.

SUBJECT: Pickleball Site Location

BACKGROUND:

New Pickleball Courts is a priority project as part of the approved Parks and Recreation Bond, approved November of 2020, and incorporated in the first bond issue.

Staff began exploring options for pickleball locations and presented five (5) potential locations at the May 11, 2021 Parks and Recreation Board Meeting. These locations are: Crestview Park, Kenning Park, Poppleton Park, St. James Park, and West Lincoln Well Park.

Since May, two surveys were conducted on Engage Birmingham. The first survey, concluding May 31, 2021 included all five (5) locations, and was a first look at the park system as a whole, to include Picklelball and to give us an idea of where the community would like to see Pickleball in the City.

The City also engaged the services of Foresite Design, a local architect with a unique and primary focus in the design and implementation of athletic and recreational facilities, to perform site assessments and potential designs for each of the five potential locations.

Staff, working through the Capital Projects Sub-Committee reviewed all feedback from the first survey and the site assessments of all five locations by Foresite Design to narrow the options 3 viable options. A second survey (Pickleball 2.0) with Crestview Park, Kenning Park and St. James Park was posted to Engage Birmingham in November, closing November 30, 2021. See attached survey response report.

Considerations throughout this process include, but are not limited to: number of pickleball courts to offer per site, site amenities including shade structures and gathering areas, parking, current uses of the park, future planned projects, proximity to nearby residents, and ADA accessibility. Goals were set to provide at least 6-8 pickleball courts at each location, have adequate parking available nearby, and to maintain existing park fields, playground and court areas.

PUBLIC COMMUNICATIONS:

This project has been a reoccurring communication item on the Parks and Recreation Board agenda since May, 2021. Public input has been received at the board level, over Engage Birmingham surveys (2), and via email.

SUMMARY:

Each of the three potential locations with corresponding survey results, and advantages/disadvantages, existing and/or future planned park features and activity is described below:

Crestview Park

- #5 ranking from May 2021 survey
- #3 ranking from November 2021 survey
- Enough available park space to accomplish 6-8 pickleball courts with the elimination of 1 tennis court from inventory
- On street parking available (may need to add signage)
- Room for Site Amenities (seating, shade canopies, gathering area)
- Minimal residential proximity (sound)
- Current Park activity: Open space available for Soccer, Tennis, Playground
- Art piece consideration at the corner of Southfield and Southlawn

Kenning Park:

- #1 ranking from May 2021 survey
- #1 ranking from November 2021 survey
- Enough available park space to accomplish 6-8 pickleball courts
- City Parking available across the street (may need to add crosswalk, signage)
- Room for Site Amenities (seating, shade canopies, gathering area)
- Minimal residential proximity (sound)
- No conflict with existing park fields, playgrounds or court areas- location at the corner of S. Eton and Lincoln noncontiguous with rest of park

St. James Park:

- #2 ranking from May 2021 survey
- #2 ranking from November 2021 survey
- Enough available park space to accomplish 6-8 pickleball courts with the elimination of 1 tennis court from inventory
- City Parking lot available
- Room for Site Amenities (seating, shade canopies, gathering area)
- Minimal residential proximity (sound)
- Possible future site of splash pad-possible intensive programing
- Current Park activity: Baseball, Tennis, Playground, YMCA park permit-day camp

The Capital Projects Subcommittee met on December 2, 2021 to review the results of the November 2021 Pickleball 2.0 survey (attached), and discuss site location options. The recommendation is to move forward with Kenning Park as a site for Pickleball. A City Departmental review and comment period of this location will be conducted as a next

step. Additionally, because of support for each location, although proceeding with Kenning Park at this time, it should be noted that Crestview Park and St. James Park can remain options for Pickleball as future park improvement opportunities arise in the next phase of available bond dollars.

SUGGESTED RESOLUTION:

To support Kenning Park as a proposed site for new Pickleball Courts, pending departmental review, and to forward to the City Commission for their consideration. Further, to recommend proceeding with design development services including construction drawings and bid documents with Foresite Design, Inc.




Q1 Which location do you like best for Pickleball in Birmingham?

SUBJECT: Ray Katz "Astral Projection" – Art on Loan Application

Artist Ray Katz submitted seven sculptures for the Public Arts Board to consider as a part of their 2021 Call For Entry. All sculptures were proposed as loans to the City.

On July 21st, the Public Arts Board reviewed the various sculptures and narrowed down their preferences to "Astral Projection" and "Burst". In regards to preferred location, the greenspace at S. Old Woodward and Woodard, south of the 555 building included in the Call-For-Entry could potentially work, however the Board felt that another location could be considered. The PAB felt that a larger, more prominent sculpture should be pursued at the S. Old Woodward & Woodward gateway.

The corner of Southlawn and Southfield Road at Crestview Park was proposed as another possible location. This area does not have a sculpture and could be a good location where Southfield Road acts as a type of entryway to Birmingham. Rendering at this location were requested for the next meeting.

On October 20th, 2021, The Public Arts Board reviewed renderings of "Astral Projection" and "Burst" at the proposed location of Crestview Park near the corner of Southlawn and Southfield. The PAB liked the variety of colors, shapes, and height that "Astral Projection" would bring to the area. The PAB also preferred the one base pad that would be required for installation and would be more ideal for a sculpture on loan. The PAB moved to recommend approval of the sculpture on loan titled "Astral Projection" by Ray Katz to be located at Crestview Park near the corner of Southfield and Southlawn.

Since recommending the location at Crestview Park, the PAB has learned that the area is in consideration for new pickle ball courts. On November 17th, 2021, the PAB discussed the possibility of new courts in the area, and decided to wait until the Parks & Recreation Board made a final determination for the new pickle ball court location. The PAB determined they would reconsider the location for the sculpture if the Parks and Recreation Board selects Crestview Park for the location.

Recommended Action:

Move to recommend approval of the application for the sculpture on loan titled "Astral Projection" by Ray Katz to be located at Crestview Park near the corner of Southfield and Southlawn.

Artist Ray Katz submitted seven sculptures for the Public Arts Board to consider as a part of their 2021 Call For Entry. All sculptures were proposed as loans to the City.

On July 21st, the Public Arts Board reviewed the various sculptures and narrowed down their preferences to "Astral Projection" and "Burst". In regards to preferred location, the greenspace at S. Old Woodward and Woodard, south of the 555 building included in the Call-For-Entry could potentially work, however the Board felt that another location could be considered. The PAB felt that a larger, more prominent sculpture should be pursued at the S. Old Woodward & Woodward gateway.
