COMMUNICATION/DISCUSSION ITEM #1: Public Arts Board Update

PM Laird reviewed with the Parks and Recreation Board the Public Arts Board Update Memorandum from Brooks Cowan, City of Birmingham Senior Planner.

PM Laird stated that the piano will return at Shain Park, similar to 2019. The Public Arts Board will be hosting a piano painting event at St. James Episcopal Church and then the piano will be placed beneath the Shain park pavilion.

PM Laird also stated that Detroit Institute of Art's Inside Out program will be returning to the City of Birmingham Parks which will include six locations.

Graham asked that social media outlets be used to communicate and publicize these two items.

No Action was taken by the Parks and Recreation Board

COMMUNICATION/DISCUSSION ITEM #2: Project Updates

Chairperson Carmona recused herself from the Parks and Recreation Board meeting as the item 2a is related to Adams Park due to her conflict of interest with Adams Park.

Graham stepped in for Carmona.

a. Adams Park Project

PM Laird provided the Parks and Recreation Board an update. MRC the general contractor of the Adams Park Project provided a schedule with the City of Birmingham Administration.

PM Laird stated that an anticipated start date will be June 9th and with a completion dated of August 26th with a few components that will have a longer lead time.

Carmona returned to the Parks and Recreation Board meeting.

No Action was taken by the Parks and Recreation Board

b. Rouge River Trail Corridor

PM Laird provided the Parks and Recreation Board an update on a recent meeting with the consultant MCSA and reviewed the scope of work of the project, i.e., trail system identifiers, addition of new trail entryways with an addition of restroom near Booth Park, improving connectivity, adding confidence markers/signage, footbridge replacement, erosion control, while partnering with future museum improvement projects and City Engineering with future plans with cost estimates and will be return back to the Parks and Recreation Board with future public improvement.

No Action was taken by the Parks and Recreation Board

c. Pickleball Update

DPS Director Wood recapped the pickleball project progression, the mission of Parks and Recreation of providing quality recreational amenities and the importance of public engagement.

DPS Director Wood stated that Foresite Design withdrew from the pickleball project. DPS Director Wood stated a report will be going to the next City Commission meeting, recommending a conversion of the Crestview tennis courts to pickleball courts.

PM Laird stated that at a minimum the cracks will have to be repaired at the Crestview Tennis Courts.

d. Ground Water Energy Passive System

PM Laird described to the Parks and Recreation Board that Exlterra who the city has used before for tree care has been hired to install on the trail at Lincoln and Fairway Park a Groundwater Energy Passive System (GEPS).

PM Laird stated that GEPS is a system that is designed to eliminate standing water and protect underground structures from water by balancing soil moisture, allowing water to travel through the soil as needed. This water management solution is maintenance free and requires no adjustments.

e. Prescribed Burn

PM Laird stated the prescribed burns have been completed at Barnum Park and Quarton Lake area.

f. Fire Station #2 Property

DPS Director Wood stated a concept plan for a pocket park located at fire station #2 is under development by a local architect.

g. Ice Arena Mural Contest-Engage

PM Laird communicated that the mural contest has kicked off on Engage Birmingham and has been posted to the city website with a deadline of May 20, 2022. The communication director has shared this event with all social media channels and has been distributed to the Birmingham school district for distribution.

ADAMS PARK PROJECT TO BEGIN EARLY JUNE

The Adams Park Project will take place from approximately June 9, 2022 through August 26, 2022.

Project Overview

This project is made possible by the approved Parks and Recreation Bond of 2020. Enhancements to Adams Park will include a significant play area, a garden seating plaza with a pergola, beautiful landscaping improvements with lots of new trees, benches, an open grassy area large enough for a soccer field, a basketball court, and track and field elements.

Construction Traffic

Vehicles will enter and exit the park on the south end, from Ridgedale. All construction vehicles will remain inside of the enclosed construction site.

Project Timeline

Mobilization and demolition will take place beginning around June 13. A temporary construction fence will be installed during this time. Grading work will take place over the following 8 weeks. Concrete construction and site utility work will begin late June, early July and continue through July. Installation of site amenities, play equipment, and landscaping will occur in August.
