## Agenda item #1: Request for Art Donation Installation: Tom Fitzgerald – "Khyber" – Art on Loan Application

Carmona opened by introducing Brooks Cowan, City Planner and liaison to Birmingham Public Arts Board.

Cowan stated the sculpture titled "Khyber" is provided as a permanent donation to be considered the property of the City of Birmingham, placed in Fairway Park where the Fairway Trail hits Fairway Drive and will be installed on a standard concrete base, similar to the art installation at the Baldwin Public Library.

Rusche inquired whether an artist's statement would be included with the piece. Cowan said that the artist would be identified on a small bronze plaque and a more detailed description would be provided online at Bhamgov.org/art.

Kaplan inquired about artwork maintenance because the application for Art in Public Spaces indicated that "Khyber" may require occasional touch ups with high gloss black paint. Cowan replied that the city budgets for maintenance for all art installations.

It was moved by Lipp, seconded by Collins to recommend the location of Fairway Park indicated in Exhibit A for the installation of the sculpture "Khyber" by Tom Fitzgerald.

### Agenda item #2: Crestview Park- Pickleball Courts Recommendation

PM Laird provided a Request For Proposal (RFP) status update and recommended the Parks and Recreation Board approve single bidder, Goddard Coatings to complete conversion of Crestview Park courts to six (6) pickleball courts and further recommend this project be considered for approval by the City Commission.

PM Laird provided a memorandum which provided project background, status, reviews, fiscal impacts, recommendations, as well as the contractor proposal and related attachments. Goddard Coatings' proposal did not commit to a September 30, 2022, project completion deadline, due to a backlog of work and committed schedules; however, they did state in their proposal they would do their best to meet such a deadline.

PM Laird stated that Goddard Coatings did not include a provision for an alternate sound dampening fence. PM Laird will be exploring other sound barriers for future installation.

Rusche asked if illustrations would be provided to the City Commission and PM Laird replied that the drawings provided by the prior consultant would be utilized.

Collins wondered if the recent crack repair would be covered by the general maintenance fund.

PM Laird explained when that funding approach had been delayed as a capital project because no funding was available, so bond money was utilized.

Carmona suggested that \$55,000 had been estimated, so despite only having one bid response, the proposal's \$63,750 appears reasonable. PM Laird added known contractors are booked for the season.

DPS Director Wood described the city is pushing the contractor for completion this year and offered that the city has previously had great experience with Goddard Coatings: they have a great local reputation and are a subcontractor in the Adams Park project. Additionally, DPS Director Wood reached out to another contractor to respond to the RFP (for pricing comparison), they indicated they were extraordinarily busy this season yet would try to submit a proposal.

In order to not jeopardize the tight project timing, the plan is to bring the proposal to the next City Commission meeting.

Kaplan asked about receiving a single bid. DPS Director Wood explained that more responses are preferred but single bids are not uncommon.

Collins asked if there had been any noise complaints, and PM Laird and DPS Director Wood indicated that none had been received.

Sweeney said he had used the temporary pickleball courts at Crestview Park and loved them.

Carmona thanked Sweeney or his efforts, advocacy, and feedback.

Linda Forrester stated that she was talking to DPS Director Wood about setting up specific times for group play on the reservation system.

DPS Director Wood stated that the city does not program and the reservation system is used for other facilities and moving forward the reservation system could be used for pickleball reservations but that has not been determined yet.

Linda Forrester suggested an open house and have set aside specific times for group play, e.g., nine o'clock to eleven o'clock in the morning, so that players know when to show up to play in a group.

Carmona stated that Linda Forrester is welcome to do that now; however, the city is not prepared to program pickleball or utilize the current reservation system at this time.

DPS Director Wood stated that during the conversation with Linda Forrester, there would be an evaluation of using the reservation system for reserving pickleball courts on specific times and to communicate through the city social media communications after the Crestview Park tennis courts has been permanently converted to pickleball courts.

Carmona suggested a better understanding of the constraints and role of the City as it relates to procedures and staffing and what would be useful.

Sweeney identified as an avid pickleball enthusiast, two (2) factors with the current temporary pickleball courts at Crestview Park that influence local pickleball players' engagement.

- Limited number of pickleball courts currently there are two (2) pickleball courts where most pickleball players expect six (6) or eight (8) courts
- Temporary markings over existing tennis court lines

These factors have contributed to local enthusiasts to utilize the Crestview Park pickleball courts as an alternate.

It was moved by Sweeney, seconded by Kaplan to approve the project for Crestview Park pickleball courts with Goddard Coating Company and further, to recommend this project be considered for approval by the City Commission.

PM Laird confirmed the project is on track and reviewed construction progress, concept rendering, and current photos. Concrete work has begun, play area is carving out, the basketball court and track and field elements are shaping up, and the beautiful, stately centerpiece tree is in place (located in the central gathering area). Thirty-eight (38) truckloads of debris have been removed and boulders have arrived. The playground equipment is coming soon. The project is on time and should be finished before school begins this year.

Carmona inquired about neighborhood concerns. PM Laird said mostly positive feedback has been received.

Lipp inquired about a ribbon cutting ceremony. PM Laird confirmed that a ribbon cutting ceremony is being planned.

Goulding asked if donations are still being accepted and PM Laird said we still are but none have been received.

Carmona was assured by PM Laird that the City does not anticipate the newly installed Elm to outgrow the circular concrete pad at the base of the tree. **No Action was taken by the Parks and Recreation Board** 

### b. In The Park Concerts – Shain Park

RC Folk shared there have been no cancellations so far this season and the events have been well attended.

#### SUBJECT: Station #2 Concept Plan

Expressed interest in utilizing the city property located at 1600 W. Maple, otherwise known as Fire Station #2, as a park by surrounding residents the and community prompted a review of the area, discussion and potential viable options for your review. By way of background, please see the attached information on this property.

The attached proposed plan has been provided at no cost by Christoper J Longe, Architect and Interior Design.

Concept Plan Points of Interest - shown on concept plan with correlating keynote numbers:

Pergola Structure and Planting Area Backdrop

- provides a seating and shading area (1) (2) (3)
- screens home to the north
- intentionally set back off of Maple to create and define north end of "outdoor room" (8)
- together with south wall- creates and defines play area (4)

#### Play area:

• open space (4)

#### Extension of wall

- south wall extension to semi-enclose park and define south edge (7)
- buffer from traffic, barrier for kids using the play area/chasing ball into W. Maple

#### Angled wall

• thickened, becomes seating wall (5)

#### Flower Bed

 corner terminated with flower bed to soften edge created by the intersection of sidewalk/streets (6) The concept plan is presented for your review, to receive feedback and public input. It should be noted that this project came before us after the Parks and Recreation Bond priority list was set and there is currently no designation of funding for this project, bond dollars or otherwise. A cost estimate has not been determined at this time, as this is the initial public review of potential park features and elements.

As we develop our next five (5) year Parks and Recreation plan in the coming year, we hope to include this area as a future capital project item, and will continue discussions on budgeting, prioritization of this project vs. other identified projects, and donation opportunities and naming rights.



#### INTRODUCTION:

There is interest and ongoing conversation from community members about designating an existing public property (known as the Chesterfield Fire Station) as a City park. In addition, to consider naming the park in honor of a local resident. Last year, a proposal and petition for a new park and playground located at Fire Station #2 was presented to the Parks and Recreation Board at their August 11, 2020 meeting. The Parks and Recreation Board took no action. However, the Administration informed the presenter, Kate Bongiorno that further consideration and communication can occur about this idea after the Parks and Recreation Bond proposal in November 2020.

Some park elements proposed at the corner of this parcel are an all-inclusive playground structure, benches, picnic tables and a gazebo, among other suggestions. There is not a concept plan, to date, for the proposed suggested site amenities. Of course, this would be a good starting point, in order to provide estimated construction costs.

#### BACKGROUND:

As part of the City property inventory, the Chesterfield Fire Station is a named property for use as a fire station. The location is on Maple Road between Chesterfield and Fairfax. The total area is 1.36 acres. The portion of this property to be labeled as a City Park is on the east side of the new fire station and comprises approximately .60 acres.

This property is zoned Public Property (PP), which is similar to all other public property including those sites classified as parks. There is no Park designation under the Zoning Code. For size comparison purposes, Adams Fire Station is 1.05 acres.

In July 2020, the City Commission identified park and recreation projects to be part of the local ballot proposal for \$11,250,000. The proposal to create a park at Fire Station #2 was presented after projects were included with the Parks and Recreation Bond proposal.

Since the passing of the Parks and Recreation Bond proposal, we are moving forward on several initiatives as part the recommended project priority list. The overall Parks and Recreation Master Plan identified several capital improvements projects at numerous City parks, new playgrounds and improvements to the Rouge River trail system. This proposal is not part of the overall parks and recreation initiatives.

As part of the due diligence in reviewing and making a recommendation back to the City Commission on this issue, the Administration will examine historical records and background information on other similar naming protocols of City parks, facilities and the like. There are examples from the past for which we can draw from as part of this review.

A donation is not being proposed as part of this request, but there is certainly a potential opportunity for donations to be part of any future park development. I have included a copy of the Parks and Recreation Donor Policy adopted in October 26, 2015 by the City Commission.

#### LEGAL REVIEW:

There is no legal review at this time.

#### FISCAL IMPACT:

New park and playground located at Fire Station #2 was not part of the Parks and Recreation Bond allocation, since it came up afterwards. Therefore, at this time, this park development is not included in the bond dollar distribution. There has been no funds budgeted in the current fiscal year budget for any park improvements at this site.

#### PUBLIC COMMUNICATIONS:

Public input will be ongoing, to be gathered at the Parks and Recreation Board and City Commission meetings. Opportunities to include social media tools for additional feedback about this issue. Communications will be underway between City Administration and various City Departments.

#### SUMMARY:

Several issues need to be addressed as part of the review by the Parks and Recreation Board. These may include some of the following items. 1. Examine zoning issues and park designation steps. 2. Does this limit or restrict Fire Station uses and future expansion? 3. Review potential site amenities and probable costs, based on size and space restrictions. 4. How do we initiate naming opportunities, review past examples of City Commission actions. 5. How do we go about finding fundraising opportunities? 6. Examine potential financial impact and funding sources.

Dear Birmingham City Manager Valentine, City Clerk Allen, and Esteemed Commission Members,

I would like to request and encourage your consideration of the creation of a 15th Birmingham City Playground in Quarton Lakes Estates.

This idea was hatched about a year ago when my friend (and fellow Birmingham resident) and I took our kids to visit all 14 Birmingham playgrounds in one day. It took us six hours and we enjoyed the variety of landscapes and playscapes and the opportunity to explore Birmingham. On our drive home, my kids and I wondered why our neighborhood was missing a neighborhood playground?

I subsequently shared my thoughts with other friends in the neighborhood and one, who I must take a moment to spotlight as one of Birmingham's most loyal citizens, Patricia Andrews, suggested that the greenspace adjacent to the beautiful new Fire Station #2 might be a good location to build a playground in the neighborhood.

I could not agree with her more!

The space next to Fire Station #2 has ample space to create a safe, pleasant, inviting space for recreation and relaxation. It has easy pedestrian and bike access from Fairfax, Chesterfield, and Maple Roads. In addition, it boasts street parking, complimentary nearby local businesses to visit for a snack while playing, a tony new fire station that is well-known by children in the neighborhood, and nice, established features of shade, safe distance from the roads, and access to the Fire Department in case of emergency.

This proposed playground space will offer a wonderful place for community connections!

The churches along Maple Road house many preschools and the playground will offer a welcome option for parents with younger siblings who have a couple of hours to play in between drop-offs and pick-ups at Quarton, West Maple, Hand-in-Hand and First Kids Preschools. For residents who are retired, a beautiful outdoor space with tables and benches will be a terrific location to meet up for coffee and conversation or gather for a game of chess, cards, or dominos with friends and neighbors... and fresh air.

Quarton Lakes Estates is a neighborhood with a population mix of families and retirees. A playground and park will create an ideal space for neighbors who otherwise miss one another due to different schedules and lifestyles to meet and socialize in a casual, outdoor setting. It offers intersections for neighbors to meet and get to know one another, which is vital for creating strong, connected neighborhoods and communities. As I shared this idea with my friends and neighbors, it was equally embraced by the young and the young at heart, individuals with children and those who enjoy being around children.

The creation of Birmingham's 15th playground has tremendous merit at face value, but there is *so much more* potential that comes part and parcel with its construction.

The park could be a great venue for residents to rent for birthday parties, scouts or sports team picnics, or school parties. While offering a safe option for social events, it could also generate a nominal source of revenue to support maintenance costs. Similarly, a structure such as fence or pathway could be constructed through donations and offer a place for residents to donate to their local neighborhood gathering space and "leave their mark" with an inscribed fence plank or brick or stone.

The park could also be a great place for the City to offer exciting, low-cost, high-impact events such as book readings, concerts, or holiday gatherings to promote community... and even spotlight rising poets, musicians, artists, or tastemakers living right next door who might happily share their talents with their neighbors on a sunny afternoon at the park?!

I propose that the space is simple but can impactfully multi-task: picnic tables and benches, garbage and recycling cans, a water fountain, a sandbox or Gaga Pit, a mix of toddler and youth, ADA inclusive swings, a slide, and basic climbing structure. The space could also potentially accommodate a basketball hoop and park exercise equipment that would be equally enjoyed by teenage and adult parkgoers *and* our loyal firefighters during downtime at the Station.

In addition, I suggest adding features that invite community collaboration: small gardens that could be adopted by residents, student groups, or schools; Book Walks that could be guided by friends at the ever-improving Baldwin Library; fairy gardens or nooks broadcasting positive, inclusive messages; a Little Library; a kiosk or message board where the City or residents could post useful, neighborly information (i.e. items for sale, new social groups, events, missing pet notices, etc.); and a hallmark feature to make the playground really unique such as a community-member created Art installation, a fence with love locks, a gazebo, a pine tree where ornaments could be displayed for seasonal holidays, or a take something/leave something surprise box.

The sky's the limit with opportunities to turn the beautiful space flanking Birmingham's impressive new fire station into a place with even more to offer its residents in Quarton Lakes Estates.... and the Birmingham community at large!

Upon presenting the idea around my neighborhood this Spring, I was greeted with great enthusiasm by neighbors on many different streets within Quarton Lakes Estates and across all demographics. I have attached a list of residents who similarly support the proposal of a playground in our neighborhood. Moreover, in these uncertain times, I believe a safe, new, exciting open space, out of doors might be just what Birmingham needs to inspire hope and offer new opportunities for safe social engagement.

On behalf of my neighbors and myself, thank you for your consideration of this community improvement as well as your ongoing dedication to Birmingham, City Manager Valentine, City Clerk Allen, and Councilmembers Longe, Host, Hoff, Baller, Boutros, Nickita, and Sherman.

## **City of Birmingham Parks and Recreation Donor Policy**

Thank you for considering Parks and Recreation in the City of Birmingham for your donation. We welcome donations from individuals, foundations, non-profit organizations and corporations and look forward to working with you.

While donations for our parks will enrich the community, the City of Birmingham recognizes that its open spaces, trails and recreation areas are precious resources. Accordingly, the City of Birmingham desires to protect and preserve the open, tranquil atmosphere of our parks, to protect the natural quality of our trails and to enhance the development of our recreational assets. Therefore, donations for park improvements and recreation programming will be considered with the support of those goals in mind.

## I. DONATION CATEGORIES

The City of Birmingham welcomes donations in several categories including:

- a) Park landscaping elements include trees, shrubs and other flora. Donations of all landscaping elements, however, must be approved species and there may be site specific limitations. Please see the City of Birmingham Park Donor Program for further information.
- b) Park amenities for the purchase, replacement or refurbishment and maintenance of park benches, picnic tables, drinking fountains, bicycle racks, playground components and the like. Although suggestions from donors will be considered for the placement of a donated park amenity, final decisions as to location will be determined by the City of Birmingham. Please see the City of Birmingham Park Gift Donor Program for further information.
- c) Park features include arbors, pavilions, plazas, gardens, and the like. Such features must enhance the park, enrich the experience of park users and be consistent with park planning processes. Accordingly, such proposed donations will only be considered on a case-by-case basis. Donors may contact the City of Birmingham or the Director of Public Services to discuss proposed park features.
- d) Monetary donations, such as cash or negotiable securities, may be used toward the development and general upkeep of park elements, amenities and features. Donors may identify a specific use for the City's consideration, or funds may be used to best meet the needs of the City of Birmingham Parks and Recreation projects.

## II. DONATION GUIDELINES

In order to have a consistent donor program, the following guidelines endeavor to address both the needs and resource capabilities of the City of Birmingham and the desire of donors to support Birmingham's Parks. Donors should contact the Director of Public Services to discuss donation ideas.

a) The City wants to ensure the best appearance and aesthetic quality of its parks. Thus, donations should satisfy a true need of an approved park scheme.

## II. DONATION GUIDELINES (continued)

- b) All donations will be reviewed for appropriateness and compatibility with the City of Birmingham Parks and Recreation Master Plans. The City reserves the right to decline any donation if, upon review, the donation is (1) limited by special restrictions, conditions or covenants which pose unreasonable budgetary or maintenance obligations on the City, or (2) not in the best interest of the City.
- c) Donors may be asked to appear before the Birmingham Parks and Recreation Board and/or the City Commission, to present their donation proposal. Public comment and feedback may be considered during the review process.
- d) The City understands that donors may have preferences regarding the choice of design professionals, vendors and contractors, and preferences regarding the location, size, scale, color and materials of donated elements, amenities and features. The City, however, must adhere to the open bid process requirements, if applicable, and to other City policies and goals. Accordingly, final decisions on all details of the proposed donation shall be at the sole discretion of the City of Birmingham.
- e) While the City recognizes the generally good intentions behind any donation, the City, at its sole discretion, reserves the right to decline any gift or donation.
- f) Upon acceptance by the City, any donated element, amenity or feature, becomes City of Birmingham property. The City has an interest in ensuring that all park elements, amenities and features remain in good repair and will provide, at its sole discretion, reasonable maintenance of donated items. The City, however, is under no continuing obligation to repair, replace or maintain perpetual care for any donated item.
- g) The City will make a reasonable effort to notify a donor of any damage, theft or other loss to a donated item and may, at its sole discretion, repair or replace such a donated item to the extent it deems practical, or as described in the original gift agreement, if any.
- h) Because donations to the City of Birmingham may be tax deductible, donors are encouraged to consult with their tax advisor.

## III. DONOR RECOGNITION

- a) Recognition shall be provided for all gifts given to the City of Birmingham for park improvements, subject to such general policy changes and amendments as may be implemented by the City Commission.
- b) "Naming rights" on any park feature or element are subject to the approval of the City Commission.
- c) All donations will be acknowledged by a letter of appreciation from the City of Birmingham.

SUBJECT:	Fire Station 2 Park Consideration

The City of Birmingham's Fire Station 2 (previously known as the Chesterfield Fire Station) was rebuilt and opened in October 2018. The Station is situated on a lot of approximately 1.37 acres; half of which is developed. The eastern parcel of the property is an open field with some adult trees. Station 2 is staffed 24/7 with four personnel consisting of three Firefighter/Paramedics and one Lieutenant. These positions staff an advanced life support (ALS) engine and an ALS rescue.

With the possibly of having a park built on the eastern property I have some concerns and requests which I have listed below.

- The fire station can be a busy place with trucks leaving emergent and backing into the station after details or emergency calls. There is concern that a park located directly on the same parcel could lead to unattended children getting close to the emergency apparatus. Additionally, fire trucks do not have lockable doors or keys for the ignition. They are often unattended while fire fighters are inside getting supplies or training.
- Periodically, the fire crews flow the fire engine master streams onto the parcel in consideration. This is an annual requirement to test the fire pump and its capabilities. It is also done for training purposes throughout the year. The amount of water flowed is around 1,500 gallons per minute which can very quickly soak down the area. Hose streams from portable hand lines are also deployed during training into this area.
- The considered park is also close to a very busy roadway. I have concern for unattended children chasing balls into the street.
- With the ever increasing role of the modern firefighter and the possibility of potential unforeseen growth in the department, this property must always remain available to the Fire Department. Future needs may require expansion of the current Station 2, addition of a separate training facility, etc.
- Fire Station 2 also has one of Oakland County's emergency alert severe weather sirens located behind the station. This gets tested 8 times a year and will be extremely loud with its close proximity to the parcel in consideration.

• Station 2 is a secure building and often is not occupied when firefighters are on a detail or emergency call. There are no public restrooms at Station 2. Additionally, there is no access to tap into the Station's sewers or water supply on the east wall to have an outside bathroom for the park. I have concerns that there will be frequent requests to use the bathroom, creating issues due to the lack of public facilities at Station 2.

Consulting City Engineer Surhigh summarized the item. In reply to Commissioner Hoff, he stated that an expression of interest would be solicited from residents once the Engineering Department completes its unimproved streets rankings.

CM Markus added that the City would provide the residents of unimproved streets with an estimate of the approximate costs of improving their street. He said this process moves the City more towards initiating the process of improving streets versus only waiting for resident petitions as was done in the past. ## COMMUNICATION/DISCUSSION ITEM #1: Pickleball Sites – Public Input

Carrie presented to the Parks and Recreation Board a pickleball presentation. Carrie pointed out five potential locations of new pickleball courts which where Crestview Park, Lincoln/Eton Corner (Kenning Park), Poppleton Park, St. James Park and West Lincoln Well.

Carrie stated that there are two options to either provide new pickleball courts or to convert tennis court(s) into pickleball court(s).

Carrie stated that staff reviewed all the City of Birmingham Parks and took into consideration spacing requirements, other programed activity, proximity to other nearby parks with tennis courts, nature of park- active/passive and other items that the public might not be aware of.

Carrie stated other considerations such as parking, ladder leagues (6 to 8 courts needed), ADA- curb cuts, sidewalk up to and surrounding, site furnishings- tables, spectators, restrooms, proximity to nearby residences- sound attenuation/visual separation, tennis players, other current park activity, new vs. converting existing tennis courts.

Carrie showed the Parks and Recreation Board how new pickleball courts would fit at each of the five locations either for new pickleball courts or converting the existing tennis courts.

Carrie stated that \$150,000 has been estimated in constructing six to eight new pickleball courts.

Carrie stated that the new Engage Birmingham survey System was used for public input. Carrie will provide to the board an update on the rankings at the June Parks and Recreation Board meeting.

Carrie reviewed with the Parks and Recreation Board the 2020 tennis reservations that were reserved through our Parks and Recreation software at the seven City of Birmingham tennis courts.

Ross Kaplan said it's his opinion that to be cautious with the number of tennis reservations reported are since only 25-30% of Birmingham residents actually make making tennis reservations.

Pam asked if the staff had look at the possibility of using the tennis courts for both pickleball and tennis as a shared use.

Carrie stated the staff would have to explore the possibility of a shared use for both pickleball and tennis.

Carrie stated that at a future Parks and Recreation Board meeting a recommendation will be brought to the board for approval for a pickleball location and that tonight's meeting is just to receive feedback.

Dominick stated that the board may want to have a conversation about pickleball and splash pad together so that the board can make more of a holistic assessment of all the facilities and make the best determination for the residents.

David Young stated he is not an advocate of converting tennis courts to pickleball courts and the city should build new ones and the online tennis reservations is not necessarily the true reflection of demand for tennis.

David stated frequently he will show up at the tennis court and there are people just playing at the tennis court casually, so he thinks staff should look at the total demand rather than the reservation demand. David stated he would advocate building new pickleball courts.

No Action was taken by the Parks and Recreation Board

## **COMMUNICATION/DISCUSSION ITEM #2a-2d: Fire Station 2 Park Designation Request (City Commission Report dated March 30, 2021)** Lauren stated there is interest and ongoing conversation from community members about designating an existing public property (known as the Chesterfield Fire Station) as a City park.

In addition, to consider naming the park in honor of a local resident. Last year, a proposal and petition for a new park and playground located at Fire Station #2 was presented to the Parks and Recreation Board August 11, 2020 meeting.

The Parks and Recreation Board took no action. However, the Administration informed the presenter, Kate Bongiorno that further consideration and communication can occur about this idea after the Parks and Recreation Bond proposal in November 2020.

Lauren stated to the board that in addition to the August 11, 2020 Parks and Recreation Board Agenda Item #2 and meeting minutes, City of Birmingham Parks and Recreation Donor Policy, also included is the City Commission Report dated March 30, 2021, email received from Commissioner Rackeline J. Hoff, memorandum from Fire Chief Paul Wells and the City Commission draft minutes of April 26, 2021.

Lauren stated that moving forward staff would have to do some research on evaluating the proposed property, how much space that is available, what would it take dedicate or earmark as a park. The public property is designated as a fire department.

## Parks and Recreation Board Meeting 5/11/2021 4

Since this project was brought to the August 11, 2020 Parks and Recreation Board meeting it was not considered part of the allocation of the bond and was not one of the priority projects. The project will be ongoing and the Parks and Recreation Board will be given intermittently updates as this project moves forward.

John stated that the idea is wonderful and the concept of the park is interesting but finds it difficult to overcome the comments from Fire Chief Paul Wells and Ms. Hoff. If the development of that park had picnic tables and things that may be suitable for adults that would be an interesting idea. But to encourage children to come to a park that is right on a busy street as Maple is not a great idea.

Susan stated that she loves the idea of a new park but would like to reiterate John's comments that Maple is a very busy street especially since Maple has been reduced down to two lanes and would be concerned having children playing at the proposed park. Susan likes the idea about placing some seats at the proposed park location.

Dominick also in agreement with the concerns as stated in particular from the fire chief. Dominick asked if it would make sense to consider that location for pickleball as it perhaps skews towards older users and would alleviate younger children playing near a busy road but not sure however if this addresses the consideration of the fire chief for future expansion, hose drainage and training.

Heather stated she agrees with the comments made by John, Susan and Dominick. The idea and the premise behind the neighborhood wanting to do something to activate that space should be commended but believe that are some options and flexibility not only safety, to install some benches and trees and not to make a large investment into the area because of possible future expansion but to make it a respite area instead of a place to play.

Pam asked that staff contact Kate Bongiorno and give an update on the progress of the proposed park. Lauren stated that there continues to be communication with Kate, although Kate is no longer a Birmingham resident.

#### INTRODUCTION:

The Department of Public Services (DPS) was asked to examine and report on the history of the designation of both parcels as park property and status of the two City owned parcels along Southfield Road. These are referred to as the South Well Site, which is broken into two small parcels, located at the SW corner of both Southfield Road and Wakefield and Southfield Road and Southfield Road and Southfield Road.

#### BACKGROUND:

The southernmost property next to Market Square is .17 acres consisting of Lots 301, 302, 303 and north ½ of Lot 304. Historically referred to as Southfield Well Site. It was conveyed to the City of Birmingham in August of 1940 for the purpose of a well site. The City parcel located at the SW corner of Southfield Road and Southlawn is .52 acres consisting of Lots 291 to 298. Conveyance occurred in February of 1941 for the purpose of a well site. This property reverted to public use ten (10) years from the conveyance date. The well sites no longer exist. There are no deed restrictions identified with either property.

Dating back to March of 1980, we found some activity with the Planning Board and City Commission about rezoning the property (Southfield Well Site) next to Market Square from Public Property (PP) to Neighborhood Business (B-1). The Planning Board recommended that Southfield Well Site be retained in its Public Property classification and be referred to the Parks and Recreation Board for consideration as a permanent park.

The City Commission meeting of March 31, 1980 held a public hearing to rezone Southfield Well Site to B-1. The motion by the City Commission was to take no action on the proposed rezoning of this property. Comments reflected by the City Commission was to keep the property as a green area.

The Parks and Recreation Master Plan 2000-2005 lists all former well sites, see attachment, as part of the park inventory. These are all classified as Mini-Parks, based on the National Recreation and Park Association criteria and definitions. The parks along Southfield Road as part of this report have remained designated as Mini Park in every Parks and Recreation Master Plan, to date. The City Commission adopted the Parks and Recreation Master Plan on June 26, 2000. Every five years an updated Parks and Recreation Master Plan is prepared and adopted by the City Commission. The current plan is the 2018 Parks and Recreation Master Plan.

Public property often becomes incorporated into community Parks and Recreation Master Plans and in turn is designated as park property. Park space can remain passive open space or active recreational space.

#### SUMMARY:

Based on the research of both public property spaces along Southfield Road, referred to as South Well Site, we have determined the property is City owned and is officially designated as a Mini-Park in the Parks and Recreation Master Plans over the past twenty-two years based on the City Commission adoption of each Parks and Recreation Master Plan.

Many of the designated City parks in the park system are strictly open space recreation areas; as they do not have any site furnishings or play equipment. Going forward the Parks and Recreation Board will consider other public property locations to be included in the Parks and Recreation Master Plan as Public Recreation Facilities.

The DPS will be updating the current Parks and Recreation Master Plan next year and numerous public forums are always hosted by the City to gather input and foster the ongoing information exchange to create the new Parks and Recreation Master Plan. We actively engage the Neighborhood Associations and other stakeholders and groups during this process. Often included with our planning and budgeting process is generating plans and designs of public property. These will then be included in the next Parks and Recreation Master Plan.







Hi. You two get things done around there, so I trust you'll know how to convey this suggestion and to whom for the best chance of prompt response.

The new Birmingham park looks great, but expensive new plants are already severely stressed because they lack sufficient water. They could die.

The city or its contractor is watering the sod like crazy (although someone might remove some green fence cover and thus let the water hit sod already dying along the sidewalk).

In contrast, there appears to be no or severely insufficient amounts of water given to establish the new plantings. Consequently, the largest tree near the playground is suffering greatly, I'm sorry I did not take a photograph to share with you. The leaves are turning and it's not due to the season. The other trees and hydrangea plants clearly need water badly. Maybe you could ask a colleague on the Birmingham campus to take a few pictures to show you or the school's contact today, I would not delay proper watering until after the holiday given the sad condition of that large tree.

With all of its facilities and parks management people, vehicles, and staff, the City of Birmingham should well know the benefits of inexpensive water bags for establishing new plantings, plus they should soak those hydrangea root balls with a hose from whatever spigot got installed or from one of their trucks used for such watering.

Inexpensive bags like those shown below concentrate water dripping into the root ball with a steady feed, they just get refilled by hose maybe a few times weekly. They're a good substitute for a slow trickle from a garden hose right on the root ball for half an hour or so every day, that process is more labor intensive whereas the bags are set and forget for a few days before quickly refilling again.

Just based on my limited experience with new tree plantings, that big tree is in serious distress and I worry about many other of those plants making it. Will some party take responsibility or replace them if they fail and die? It's been dry, sunny, and hot here. The irrigation system does not water these new plants much if at all, besides that type of surface watering is obviously insufficient in this case and always fails to get plants properly established.

Okay, thank you for considering my suggestion to save our new trees.

The fence will remain around the park for the next two-four weeks due to fresh sod throughout the park. Staying off the sod will help ensure a healthy, durable lawn upon completion of the park renovation project.

#### City of Birmingham MI Mail - Adams Park - Home Stretch!

The grass roots of the lawn bond to the soil during the first weeks of growth, so in addition to a regular irrigation regimen, the protection of the lawn during this period is extremely important. Because the lawn requires a lot of water at first, the soil will retain a consistent level of moisture. This softer soil allows for exaggerated footprints and divots to be created by park users (people, dogs, balls, bikes) as well as lawnmowers, maintenance vehicles, and service equipment. When the soil hardens back up, these divots create trip and safety hazards for park users. This can be avoided by staying off the lawn while it is established. Thank you for helping us build a better park!

### **RE: Birmingham Country Club Sport Court Expansion**

Ms. Voelker,

Thank you for taking time with our staff recently to clarify several of the issues that the City of Birmingham was presented with in regards to the proposed sport court expansion at the Birmingham Country Club (the "Club"). On August 29, 2022, the City Commission discussed the expansion at a public meeting and heard from residents, as well as a representative of the Club. As neighbors and partners in expanding opportunities for pickleball in our own community, we would like to provide you with a few requests made by the City or Birmingham on behalf of its residents for use in the Special Land Use process:

- Post in a conspicuous location a sign outlining the rules and code of conduct expected of Club members while using Club facilities to reduce the use of vulgar language and/or distasteful activities, and to promote respectful behavior. This should serve as a reminder that the Club has residential neighbors that deserve to be treated with respect. The club representative seemed willing to post this type of signage.
- Ensure that no lighting be included in the sport court expansion.
- Adopt a policy that precludes the use of "Red Zone" paddles, which produce noise levels that may be perceived as unacceptable in the close proximity to residential zones. The Club representative suggested this item.
- A parking study should be provided and fully vetted as the Club has purportedly agreed to provide at the request of Beverly Hills.
- A sound study should be provided and fully vetted as the Club has purportedly agreed to produce.
- Establish a regularly scheduled meeting between the neighbors and the Club to discuss issues and keep the lines of communication open. The representatives seemed willing to consider this recommendation.

# Pickleball popularity soars, but expansion at Birmingham Country Club is getting pushback

Four fit grandmothers in their late 50s and early 60s faced off Thursday morning at Birmingham's Crestview Park for a quick game of pickleball, taking turns — two on each side of the net — swatting a perforated, yellow ball with a pop.

On a 20-foot wide, 44-foot long court — almost half the size of a tennis court — the women also were playing close enough to each other to hold casual conversations without much effort.

The popular summer sport with a quirky name has captivated residents in metro Detroit and communities nationwide. It also has been making headlines as publications hail it as "the fastest-growing game in America."

But even as communities like Birmingham and private country and athletic clubs are creating courts to meet the demand, there also has been pushback to the changes and what Sports Illustrated called the game's "growing pains."

One of them is less than a mile from Crestview Park, where several Beverly Hills residents are quietly organizing to prevent the Birmingham Country Club from adding courts in front of their homes.

In protest, they've lined their yards with "NO PICKLEBALL EXPANSION" signs.

S.I.'s May article — " 'Pickleball is the wild, wild West': Inside the fight over the fastestgrowing sport in America" — noted several problems, including "too many leagues," "too many federations," "battling billionaires" and "bad behavior."

The article went deep into the business considerations of the sport.

"Until recently," S.I. said, "pickleball was widely perceived as the last athletic refuge of those who had undergone a knee, hip, or spouse replacement. In reality, the sport — where 300 different paddle manufacturers bear witness to an as-yet unrealized potential — is in the throes of its terrible tweens."

## It can be an especially social sport

A big part of pickleball's appeal — particularly for the so-called "hip and spouse replacement" set — is that it is still a fast-paced game but not as physically challenging as tennis.

Balls don't go as far or as fast and the court is smaller, also making it more social.

It also has some of the qualities of badminton and pingpong.

Thursday morning, as the foursome hit dillballs and falafels — names of certain pickleball shots — there was opportunity for plenty of conversation, laughter, and even a little cooing when the granddaughter of two of the players showed up on the sidelines.

"A bunch of hotties over there," Currie Olson, 30, said to the group, which included her 58year-old mother, Kris Barich, and 61-year-old mother-in-law, Kathy Olson. She explained that she wanted to "come watch for a minute."

The younger Olson pushed a stroller with her 11/2-year-old daughter in it.

"It think it's great," Olson said of the courts. "I've seen so many more people here."

## **Outdoor rec and community clashes**

Community clashes about outdoor recreation are hardly new.

For years, suburbs and schools with basketball courts have wrestled with what to do when pickup games got too intense and boisterous. And some residents would voice concerns that those courts would attract players from "other communities."

Urban areas, like Detroit, don't always have the same kind of public recreation facilities. And when a suburb adds or upgrades a basketball court, it offers a new place for those who didn't have one at which to play.

Five years ago, for example, the small city of Pleasant Ridge wrestled with what to do with its outdoor basketball hoops at Gainsboro Park after what the city manager called "an escalating pattern" of incidents that he said included traffic violations, public urination, and drug citations.

In that case, the city's recreation commission decided to temporarily close its court.

## **Converting tennis courts to pickleball**

In Birmingham, where the fierce foursome of friends played, the city recently transformed Crestview Park's two outdoor tennis courts into pickleball courts so residents could enjoy the game.

"Once you start, you either love it or you hate it," said Carrie Laird, the city's parks and recreation manager. "It's a gathering. You come, you play, you talk. You get to meet new people — and part of the sport is the interaction with others."

And Laird, who is spearheading a more comprehensive upgrade of the courts, said the plans call for entirely upgrading the playing surface — filling in cracks and painting it — by the fall to permanently convert the space into six pickleball courts.

The cost, she said, is a small part of a more than \$11-million parks and recreation bond that was overwhelmingly approved by voters.

One of the other things that is driving the sport is media coverage.

Parade, for instance, recently published a pickleball primer: "What's all the racket about pickleball? Everything you need to know about the growing sport." The nationwide magazine is distributed in Sunday newspapers, including the Free Press.

Far fewer people play pickleball than tennis, which boasts a participation of more than 21 million. But, Parade said, the sport "has been sprouting like a cucumber vine," growing an average of nearly 12% a year for five years to reach 4.8 million.

## The game 'won over everyone'

Pickleball's origins date to 1965 as a backyard game on Bainbridge Island, Washington. Joel Pritchard, who later served the state as a U.S representative and lieutenant governor, invented the game with two buddies, Barney McCallum and Bill Bell.

There are at least a couple of accounts of why they called it pickleball. One goes that it reminded them of the pickle boat in crew; another is that it was named after the Pritchard family dog, Pickles.

The game, of course, has its own lingo.

Die-hard players, for instance, call themselves picklers.

As the sport spread, it was adopted by various groups, including community and senior centers, country clubs, and school rec and summer programs. Kids even learned how to play the game.

By 2014, the New York Times ran a speculative headline: "At tennis's sunset, pickleball is rising as an alternative," and then, last year, Vanity Fair published its take: "How pickleball won over everyone from Leonardo DiCaprio to your grandparents."

The 47-year-old heartthrob, the pop culture magazine said, plays every day.

And then, it listed off a who's who of other celebrities who also engage in the game: Larry David, Melinda Gates, Jamie Foxx, the Kardashians, Owen Wilson, Jillian Michaels, Zach Braff, and Giuliana Rancic.

It named pro athletes Russell Wilson and Annika Sörenstam and said the 61-year-old George Clooney self-deprecated that his younger wife, Amal, routinely beats him on their court in L.A.

And then, earlier this year, Washington actually named pickleball its official state sport.

## 'Much easier than tennis'

Among the women who gathered Thursday to play at the park in Birmingham, Kathy Olson, of Grosse Pointe, was the veteran. She learned to play, she said, at her country club and has been enjoying it for two years.

Jenny Shebib, 59, said the game is easy to play, and "you can get others to join up." It's "much easier than tennis," she said, leaning in and adding — as if she were telling a secret — "it's not as hard on your body."

That's because no matter how hard you hit the ball, it doesn't go far.

Barich said she used to play tennis, and likes pickleball, in part, because it's novel.

Many people just picking the game up, like Barich, are playing for fun, the women said. But, they noted, there are more competitive levels of play: tournaments, leagues and recreational courts with reservation times.

They also agreed, however, that game tends to be louder than tennis.

And with six courts going, Pattie Dull, 59, speculated, it's likely to get even noisier.

## 'All Saturday. All Sunday?'

That's exactly what residents who live on the edge of the Birmingham Country Club, where another pickleball project is planned, fear. The club, residents say, wants to add pickleball courts and is seeking approval for its proposal.

As a result, some neighbors are politely fighting the club's efforts. They are protesting with yard signs featuring QR codes that send folks to an online Change.org petition they can sign to oppose it.

Unlike tennis and badminton, which use a racket that makes a swish or soft ping sound when it comes in contact with the ball or shuttlecock, a pickleball paddle pops when it hits a ball - and that, to many, gets annoying.

On top of that, the social aspect that makes the game fun, isn't as enjoyable if you have to hear that chatter all day — or worse, the expletives when the picklers miss their shots and lose.

Lisa Hudson, 58, whose home faces the club, said in addition to the noise, she also doesn't want the bright lights the project will bring shining in her large, picture windows.

Nor does she want, she said, the additional traffic on the roadway in front of her house.

The club, which includes a golf course, has plenty of property to install pickleball courts, residents insist. So why — Hudson rhetorically asks — do they have to put them right in front

## of their homes?

"Many of us play pickleball, it's a great sport," the petition says. However, it went on to explain the group's objection to the project: "Imagine having to hear the pop, pop, pop sound of the pickleball, 14 hours a day. All Saturday and all Sunday."

The petition is seeking 100 signatures.

As of Saturday, it had 42, including Hudson's.

## Can the game's growth be slowed?

How much of a chance the Beverly Hills residents have at convincing the club to alter its plans is unclear. One challenge they face is that the club is in an entirely different municipality, Bloomfield Township.

It's also fuzzy how open the country club is to compromise.

In two separate calls from the Free Press to the club seeking its position, folks answering the phone initially said that no one was available to answer questions about its pickleball plans.

Then, they said, the club had "no comment" on the matter, and then hung up - twice.

The Free Press made a third inquiry Thursday by email, in case the message wasn't getting through to the right people, and later that day the club's General Manager Taras Strychar responded.

He said via email he was "getting ready for a couple of meetings" and not available, but offered to connect "next week."

"We are still in the planning process of the project," Strychar also wrote, adding the club is "committed to working with Bloomfield Township and the neighbors to be able to address any of the concerns they might have."

And that, the neighbors said, is all they really want: for the club to listen to them and be good sports about their uneasiness about the proposal.
