

## DUBOIS COUNTY COUNCIL

OCTOBER 12, 2022

The Dubois County Council conducted 2022 Budget Public Hearings on Wednesday, October 12, 2022, at 6:00 p.m. in the Commissioners/Council Chambers of the Courthouse Annex. Present at the meeting were Council members Michael W. Kluesner, Craig M. Greulich, Mary E. Beckman, Alex P. Hohl, Sonya Haas, Charmian R. Klem and Auditor Sandra L. Morton. Doug Uebelhor was absent. A quorum was declared present and President Kluesner called the meeting to order at 6:00 p.m.

### **RE: MINUTES**

President Kluesner asked if there were any additions or corrections to the minutes from the September 26, 2022 meeting. On motion made by Michael Kluesner, seconded by Craig Greulich, the minutes were approved 6-0.

### **RE: PUBLIC HEARINGS – 2023 BUDGETS**

President Kluesner opened the Public Hearing for comments on the 2023 Northeast Dubois County School Corporation Budget in the amount of \$10,852,919. There being no comments, on motion made by Charmian Klem, seconded by Sonya Haas, the Council voted to close the Public Hearing 6-0.

President Kluesner opened the Public Hearing for comments on the 2023 Northeast Dubois Fire Protection District Budget in the amount of \$121,250. There being no comments, on motion made by Craig Greulich, seconded by Mary E. Beckman, the Council voted to close the Public Hearing 6-0.

President Kluesner opened the Public Hearing for comments on the 2022 Airport Authority Budget in the amount of \$6,421,240. There being no comments, on motion made by Sonya Haas, seconded by Charmian Klem, the Council voted to close the Public Hearing 6-0.
