

## DUBOIS COUNTY COUNCIL

OCTOBER 4, 2023

The Dubois County Council conducted 2024 Budget Public Hearings on Wednesday, October 4, 2023, at 6:00 p.m. in the Commissioners/Council Chambers of the Courthouse Annex. Present at the meeting were Council members Michael W. Kluesner, Sonya Haas, Alex P. Hohl, Meredith I. Voegerl, Ryan Craig, Daryl Schmitt, Doug Uebelhor and Auditor Sandra L. Morton. A quorum was declared present and President Kluesner called the meeting to order at 6:00 p.m.

### **RE: MINUTES**

President Kluesner asked if there were any additions or corrections to the minutes from the September 18, 2023 meeting. On motion made by Daryl Schmitt, seconded by Meredith Voegerl, the minutes were approved unanimously.

### **RE: PUBLIC HEARINGS – 2024 BUDGETS**

President Kluesner opened the Public Hearing for comments on the 2024 Airport Authority Budget in the amount of \$5,237,740. There being no comments, on motion made by Doug Uebelhor, seconded by Ryan Craig, the Council voted unanimously to close the Public Hearing.

President Kluesner opened the Public Hearing for comments on the 2024 Northeast Dubois County School Corporation Budget in the amount of \$13,106,992. There being no comments, on motion made by Meredith Voegerl, seconded by Doug Uebelhor, the Council voted unanimously to close the Public Hearing.

President Kluesner opened the Public Hearing for comments on the 2024 Northeast Dubois Fire Protection District Budget in the amount of \$123,300. There being no comments, on motion made by Doug Uebelhor, seconded by Sonya Haas, the Council voted unanimously to close the Public Hearing.
