The Dubois County Council conducted 2022 Budget Public Hearings on Wednesday, October 13, 2021, at 6:00 p.m. in the Commissioners/Council Chambers of the Courthouse Annex. Present at the meeting were Council members Michael W. Kluesner, Craig M. Greulich, Mary E. Beckman, Alex P. Hohl, Sonya Haas, Charmian R. Klem and Auditor Sandra L. Morton. Doug Uebelhor was absent. A quorum was declared present and President Kluesner called the meeting to order at 6:00 p.m.

President Kluesner opened the Public Hearing for comments on the 2022 Northeast Dubois Fire Protection District Budget in the amount of \$118,100. There being no comments, on motion made by Charmian Klem, seconded by Mary E. Beckman, the Council voted to close the Public Hearing 6-0.

President Kluesner opened the Public Hearing for comments on the 2022 Airport Authority Budget in the amount of \$1,510,239. There being no comments, on motion made by Craig Greulich, seconded by Sonya Haas, the Council voted to close the Public Hearing 6-0.
