RE: RECYCLING MARKET

The Director reported that due to policy of China to reduce acceptance of recycling materials, the price for recycled materials had decreased. Income for the current year is approximately one-half for the same period in 2017. She reviewed the difference in price for the various types of materials: high grade plastics and white paper as compared to trash paper and low grade plastics. Therefore, the reason for separation of various materials at collection sites.

RE: WATER LEAK

The Director reported of the discovery and repair of a serious water leak at the Process Center. The Jasper Street Department was instrumental in helping to locate and prep the leak for repair.

RE: DISTRICT ACTIVITIES

The Director reported on current District activities as follows:

- The District has a limited number of special event recycling bins and doesn't have storage room for additional bins. Cannot service bins on special event sites. The District will assist organizations in the purchase of bins for long term use.
- District does not have manpower to accept additional pickup route stops.

- Have been involved in a number of educational activities at various types of public functions: including the County 4-H Fair, municipal events, medication collections.
- State is requiring monthly uploads of financial data and District has been satisfying requirements.
- Work is taking place on updating of current District Ordinances.

RE: PART-TIME POSITION

The Director has been advised that 24 hours have been approved for a part-time employee, and may be allocated between job duties as the Director determines best. This includes Ordinance enforcement.

RE: 2019 BUDGET

The 2019 Budget has been approved by the County Commissioners and Council. The Director reported that Knox County has looked at the possibility of employment of an Ordinance Enforcement Officer.

RE: DISTRICT SITES LOCATION NAME

The Board discussed the confusion associated with the names for the sites maintained by the District. The possibility of using one name for all sites was discussed. The use of "Dubois County Clean" was discussed.
