

DUBOIS COUNTY PARK

RULES AND POLICIES

This is your park! Please help make it enjoyable by keeping it clean and respecting the property, privacy and privileges of other users.

1. *Keep your area clean at all times. Place trash in available receptacles.*
2. *Do not leave fires unattended. Fires must be extinguished before retiring for bed or leaving campsite.*
3. *Rowdiness and obscene/abusive language will not be tolerated at any time. Quiet time will be observed after midnight.*
4. *No firearms of any type allowed. Discharge of a firearm is strictly prohibited.*
5. *Only one table and one campfire/fire ring allowed per camp site.*
6. *Tennis courts are to be used as tennis courts, please observe the rules posted at the court entrance.*
7. *Group parties for families or bona fide organizations must have adult supervision. An adult must accompany campers under the age of 18.*
8. *No alcoholic beverages are permitted for minors.*
9. *Observe all traffic signs as posted! Speed limit within the campground area is 10 miles per hour.*
10. *No ATV's/off-road vehicles allowed on any park property.*
11. *Camping is limited to designated sites which are available on a **first-come, first-served basis**. A site is considered occupied when a camper or vehicle is in place and the site is paid for.*
12. **Fees** (when occupying an RV campsite you must pay the RV price):
 - a. *Nightly Camping*

i. <i>Duboix County Resident</i>	\$20.00	\$10.00
ii. <i>Non-Residents</i>	\$30.00	\$10.00
 - b. *Dump Station* \$5.00
 - c. *Daily Rate for Shelter Houses*
 - i. *Shelter House #1* \$35.00
 - ii. *Shelter House #4* \$25.00

*Full payment for duration of stay is due when the site is first occupied. Place fees in drop box located within the main restrooms. Make checks payable to: Duboix County Park.
NO REFUNDS.*

13. *Maximum campground occupancy is 14 consecutive days. At the end of any camping period you must vacate the park for 48 hours. Check out time is 3PM.*
14. *You may reserve Shelter House #1 or #4 up to one year in advance by calling 812-482-2434. The reservation fee is due within 2 weeks of making the reservation or the reservation is voided. All other shelter houses are first-come, first-served.*
15. *Do not remove table from shelter houses.*
16. **Duboix County Park Board of Directors, Superintendent, and personnel are not liable for accidents or injuries or lost or stolen property.**

Violators may be subject to prosecution.**
