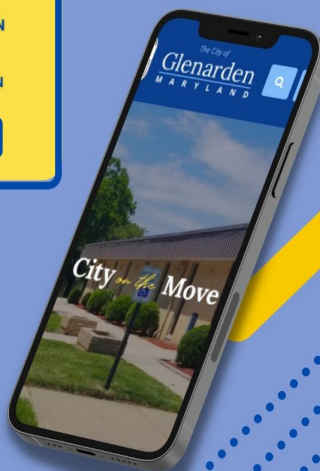

A Message from the Mayor

First of all, I would like to say what an honor it has been to be elected as your Mayor. As I took my seat over the last year the focus has been to grow successfully in unity and the mental health and wellness of our community following a fragile COVID-19 period of isolation and separation. Hard work, long hours, and much love has been put into “moving the mission forward” and it was an extreme honor to be awarded the Presidential Lifetime Achievement Medal for community service by the 46th President Joseph R. Biden, under the recommendation of the Points of Light Inspiration Honor Roll - part of The George H.W. Bush Points of Light Awards Celebration. With benevolence and the best of what God has placed in me to serve over the last year over 6,000 community service hours on the ground, 2,700 persons have received support in various forms. A Message from the City Council

The City of Glenarden City Council is excited to hit the ground running for the second year of this term. Over the last year, we've been focused on identifying opportunities to improve engagement and efficiency, alignment across City functions, and preparation for the future.

The Council has returned to Council Chambers for the Regular Meeting and Public Hearing. Residents now have several ways to participate in Council meetings: in-person, cable, Zoom and YouTube are currently available. Soon we'll be able to offer broadcast via Facebook Live. With virtual capability options, we can reach residents who may be hearing impaired or who may be more comfortable with a language other than English using closed captioning. This multi-channel approach provides greater access and engagement opportunities for all residents.

The Council has also restructured the order of Council meetings to preserve the elements of public feedback prior to voting while also optimizing the process of passing legislation. The first Monday of the month will be the Work Session where the Council will work through proposed legislation and other topics. This meeting is open to the public but closed for comment. The second Tuesday of the month is held for a Public Hearing where residents can speak on proposed legislation. This meeting may also be used for topics of significant interest to the

public, at the Council's discretion. The third Monday of the month will be the Regular Meeting where the Council will vote on proposed legislation. Residents will have an opportunity to speak on any topic at the end of the Regular Meeting.

In order to ensure the City is operating efficiently and effectively, we need better alignment and clarity across the various functions of our government. With this in mind, the Council has undertaken the task of performing a wholistic review of the City Charter. During this review, we expect to update the Charter, as deemed appropriate, to align

to state and Federal law, clarify roles and responsibilities, resolve deficiencies in understanding, make vague language more precise, and address issues that may have arisen since the Charter was last revised. We encourage resident participation in the Charter review meetings which will be held the third Thursday of each month from September-December.

We are keeping an eye on our future in various ways. With help from the American Rescue Plan Act funds of \$4.3 Million that the City received, we are helping communities recover from the devastating financial effects of COVID-19, investing in infrastructure improvements at the individual and City level, and positioning ourselves to remain a highly sought-after community for both residents and businesses. The Council has created a grant program for Homeowners Associations to improve infrastructure, established an Intergenerational Poverty Relief Fund, approved revitalization of the 7th Street Park for our children, promoted Stormwater Best Management Practices with a rebate program for individual homeowners, established a Financial Literacy Program for access by all residents, and there's more to come.

Grab our hand as we reach out for yours. Together, we can create the future you want to see. We look forward to partnering with you this year!

CITY OF GLENARDEN STORMWATER BEST MANAGEMENT PRACTICES (BMP) GRANT PROGRAM

The American Rescue Plan Act (ARPA) of 2021, will deliver \$350 billion to state, local and tribal governments to aid in recovery from the COVID-19 emergency. The City of Glenarden will receive \$4 million as a part of the State and Local Fiscal Recovery Funds (SLFRF) program. City Council has designated some of those monies as grants for eligible homeowners, businesses, and non-profits. As the City of Glenarden has been severely affected by stormwater runoff with flooding impacting many residents each year. To assist homeowners and promote environmentally friendly mitigation efforts, the City Council passed legislation to establish a Stormwater Best Management Practices (BMP) Grant Program. The goal of this program is to provide financial assistance for all eligible City Glenarden Homeowners to assist in addressing stormwater runoff at their property.

◆ Scams

There are several scams that citizens need be aware of. Grandparents, Publisher's Clearing House, Arrest Warrant, You Owe Money to IRS, House Repairs. All will try and get you to make a money transaction.

◆ Stolen Wheels

There has been multiple theft from autos in the DMV area concentrating on stealing the rims and tires from the newer model Honda Accords. They are a popular stolen item because these rim and tires fit on older model Honda Accords. If you own a newer model Honda Accord (2020-2023), make it difficult by adding additional wheel locks or turning your steering wheel to the right or left when you park your vehicle.

REMINDER OF PITBULL IN THE CITY OF GLENARDEN

The County Code. Prince George's County, Maryland. Subtitle 3. Animal Control. Division 6. Other Rules, Regulations, and Standards. § 3-185.01 Pit Bull Terriers.

Prince George's County, Maryland prohibits owning or keeping a Pit Bull Terrier with exceptions. If the person owned the dog prior to November 1, 1996, then s/he may continue to keep it if s/he complies with certain conditions, such as registering it with the Administrator of Animal Control and keeping an ID tag on the dog and keeping the dog inside or on a secure leash. Show dogs are allowed into the county on a temporary basis. Dogs that have been trained for security, search, and rescue, or for police or fire services are exempt. A violation of this ordinance may result in a fine of up to \$1,000 or be sentenced to up to 6 months in prison. In addition, if a Pit Bull injures or kills a person or a domestic animal without provocation, then it will be destroyed.

HALLOWEEN SAFETY TIPS

- ◆ A parent or other responsible adult should accompany younger children on their Trick-or-Treating rounds. Children should not Trick-or-Treat alone, regardless of their age.
- ◆ Make sure the children are clearly visible to drivers. Place glow-in-the-dark patches or strips on costumes. Carry a flashlight, glow stick, or reflective bag.
- ◆ Costumes should fit properly to prevent tripping or restricting sight or sound.
- ◆ Children should be instructed to remain outside to collect their treats.
- ◆ It is preferable that children remain in their own neighborhoods.
- ◆ Advise children to watch for traffic and look in all directions before crossing the street.
- ◆ Parents should examine their children's treats when they return home. Any candy that is not wrapped or sealed should be thrown out. If a candy item appears to be tampered with or looks suspicious, parents should notify police.

◆ **Automated Speed Enforcement Citations** - payment may be made paid my mail to the address as indicated on the citations or you may pay online at: www.OnlineCitationPayment.com. If you have trouble locating the login credentials on your citation notice, or have problems logging in, you can contact the customer service department at 1(866) 979-4824.

◆ **Accident Reports** - Accident reports are written within 72 hours from the time of the accident and available for pick-up the day after the 72 hour period.

◆ **Dispatcher** - Please call (301) 352-1200 to report a crime or suspicious action in your area and an officer will be dispatched to you through the Communication Center.

◆ **Fingerprinting** - These services are offered Monday-Friday, during the hours of 10:00 a.m. to 1:00 p.m.

◆ **Impounded Vehicle** - Once you have been notified that your vehicle has been impounded, contact the Glenarden Police Department with the case number to verify that the vehicle can be released and cost for release at (301) 772-3214.

TRASH REMOVAL SCHEDULE/RESIDENTIAL COLLECTION SERVICES

GLENARDEN SERVICE DAYS

COLLECTION TIPS



- **Monday** - Yard Waste (must be in yard waste bags or trash can marked 'yard waste' - NO Plastic bags) all loose branches must be tied up no longer than 3 feet
- **Wednesday** - Trash & Recycle
- **Saturday** - Trash & Bulk (3 items) All Mattress & box springs MUST be completely covered with mattress cover or plastic. Please note: no request is necessary for bulk trash pickup, please place your items at the curb the night before (on Friday) for pickup.

Please be advised, Prince George's County residents will be required to completely cover mattresses and box springs in a protective plastic covering. Plastic zippered mattress covers are available at many local retail stores for a nominal fee. Goode do not pick up White good items which include large appliances nor car parts & tires.

- Set out all materials by 6:00 a.m. on your collection day.
- Place bagged trash inside trash cans with lids.
- Double bag diapers and pet waste.
- Place all clean recyclable materials inside the recycling containers (i.e. paper products, plastic containers, metal containers, glass containers and newspapers).
- Recycle: No plastic bags, the only exception is clear bags used for shredded paper.
- Yard waste must use paper bags, container marked with an "X" or bundled.
- Yard waste must not exceed 50 lbs. Tree branches and limbs must be binded and not exceed four (4) feet in length.
- Mattress & Box springs must be covered (due to Bed bugs) in order for the helpers to pick up.

City of Glenarden Call-A-Bus

The City of Glenarden Call-A-Bus service offers curb-to-curb transportation for Glenarden senior citizens and adult individuals with disabilities (within the city limits of Glenarden). This service is for medical appointments, shopping, Senior Center activities, senior clubs, and other trips on a priority basis.

A lift-equipped bus is available for those in need. Please, let staff know of the need for a lift-equipped van when making a transportation appointment (reservations must be made 24 hours in advance).

A minimal \$1.25 fee each way or \$2.50 round-trip is required.
