- Citizens Comments on Pending Legislation
  - CR-XX-2022 A Charter Resolution to Amend Article V “City Manager” Section 502  
“Authority” To Amend the Line of Authority Respective to the City Manager
  - CR-XX-2022 A Charter Resolution to Amend Article IX “Personnel”, Section 901,  
“Authority to Employ Personnel”
    - **Sennieal Crutchfield** – Does not agree with removing/transferring the power to manage city personnel from the Mayor to the City Manager. How does this legislation benefit the citizens of Glenarden.
      - **President Curtis** – The City Manager is a full-time employee of the city who was hired with the intent purpose of running the city, as the Council and Mayor are only part-time.
  - CR-XX-2022 A Resolution to Amend the City Council Rules Section 308
    - **C. Wilson** – Concerned about the Public Hearing portion of the 307 & 308 legislations. Asks that the Public Hearing sections of both resolutions to be left off the resolutions. The citizens do not have the attend all meetings and request the citizens to do their research on what happened historically before you eliminate Public Hearings.
      - **E. Fareed** – Councilwoman Fareed states that the purpose of Section 308 is not to eliminate Public Hearings but to move citizens comments from that third Tuesday of the month to the Regular Meeting.
  - R-XX-2022 A Resolution to Amend the City Council Rules Section 307
    - **Julienne Vinson** – Finds it challenging to accommodate multiple council meetings in her schedule being an entrepreneur and mother. Agrees with the proposed resolution’s attempt to shorten the length of time/number of meetings it takes to pass legislation. Asks the council to adapt to the changing needs of the Glenarden citizens.
    - **Jamestina Diop** – Working as a Family Nurse Practitioner she agrees with the previous commentor that it is difficult to keep up with the high frequency of meetings to stay informed. Asks the council to find a medium with the citizens so they are able to engage and be involved



with the ongoing of the city without having to attend so many meetings.

- **C. Wilson** – in 307 under entry #2 Council Organization, the language should state that “All Council Members” should have the right to ask the treasurer about the finances of the city.

- **R. Jones** – The Public Works Department will use the plow for snow removal around the municipal center. The intent is not to remove the snow removal contract.
- **Mayor Cross** – The snowplow is for continuation and maintenance of the municipal center.
