- **R. Jones** – The April 30th Autistic Awareness Paint Party being held in the Nutrition Center; is this to raise funds for the organization? Councilwoman Jones feels the Nutrition Center is too small of a venue for an event of 50 people. Suggest asking the group to find another venue to hold their meeting, as the Nutrition Center was centered towards the Senior's Nutrition Program, HOA meetings, and community organizations and not intended to rent for events. Because there is no contract involved, the city would be liable for anything that happens. This event is also not in the city's budget to throw a paint party.
