**Reports/Incidents**

January 21st GPD Officer was actively patrolling in the 8400 block of Hamlin Street. He was alerted to a possible stolen vehicle from his mounted License Plate Reader (LPR). He requested a registration check through Prince George's County Communications on the District of Columbia Registration, which confirmed the vehicle to be stolen through Metropolitan Police Department (MPD). The vehicle, a white 2018 Nissan Altima, was observed parked unoccupied with all doors locked. The vehicle was recovered and towed for safekeeping. Prince George's County Auto Theft Unit and Teletype were notified.

January 22nd GPD Officers were dispatched to 9450 Ruby Lockhart Blvd (LA Fitness) for a Theft from auto. Upon arrival, the officers interviewed the complainant who stated when she exited the gym she noticed the rear driver-side window was shattered on her white 2018 KIA Optima. She reported someone stole her Beats Fit headphones. A view of the security did not show anything of evidentiary value or suspect information.

February 2nd GPD Officer was actively patrolling in the 3200 block of Hubbard Road. He was alerted to a possible stolen vehicle from his mounted License Plate Reader (LPR). He requested a registration check through Prince George's County Communications which revealed the vehicle was reported stolen through the Metropolitan Police Department (MPD). The vehicle was unlocked with damage to the driver's side door handle and damage to the steering column. The vehicle was recovered and towed for safekeeping. Prince George's County Auto Theft Unit and Teletype were notified.

February 3rd GPD Officers were dispatched to 9450 Ruby Lockhart Blvd (LA Fitness) for a Theft from auto. Upon arrival, the officers interviewed the complainant who stated when she exited the gym she noticed her driver's-side window was shattered on her 2004 Toyota RAV4. She reported someone stole her bag with her military identification.

Officers conducted a brief canvass of the parking lot and discovered two other vehicles with broken windows. A black 2009 Mercedes and a white 2023 Toyota Corolla had smashed windows. Both complainants stated nothing was taken from their vehicles. A view of the security did not show anything of evidentiary value or suspect information.

February 12th GPD Officer was dispatched to the 2800 block of Trotter Park Lane for a Vandalism Report. The officer interviewed the complainant via phone due to snow conditions. She reported that her and her husband were awakened by the sound of shattering glass. Her husband went to check the perimeter of their home and discovered footprints leading from the backyard to the front yard toward

her vehicle. The vehicle, a light blue 2011 Hyundai Sonata bearing Maryland registration, was found with a broken passenger back window smashed and a damaged steering column. She advised nothing was missing from the vehicle but there was damage to the steering wheel column and the vehicle was running.

February 12<sup>th</sup> GPD Officer was dispatched to the 9100 Block of Glenarden Parkway for a Theft from Auto Report. Glenarden, MD. Upon arrival on the scene, the officer interviewed the complainant. She reported that the rear window of her 2012 Hyundai Accent bearing Maryland registration was smashed and her purse and jacket were stolen. Further investigation revealed damage to the vehicle's steering wheel column.
