#### Mayor Report (October 01- November 27, 2021)

- 1. Accomplished:
  - a. HR actions are underway for the Director of Public Works (selection made passed to City Council for confirming), Chief of Police (selection made passed to City Council for resolution confirming), Treasurer (selection made passed to City Council for resolution confirming), Part-time Code Enforcer (notified as of 11/23/2021) HR is in need of a significant written and budgetary re-evaluation of all major position descriptions to ensure the right expertise is being requested to support the mission ahead for the City of Glenarden.
  - b. The Mayor's Office has been extremely busy supported/fielded nine external office calls. (Glenarden Housing Authority (Newest Commissioner resume sent to City Council), Witness swearing in of newest Delegate Faye Howell District 24; Community Forklift Chris Melendez Administrative and Operations Project Coordinator and Nancy J. Meyer Chief Executive Officer & Chief Operating Officer (free to reduced building and home furnishings for the community atlarge); Community Mayor's meeting with Mayor Johnathan Medlock District Heights, Judge Sylvania Woods Elementary School healthy eating program recorded for channel 9 news; Prince George's Stand and Deliver increased support to Glenarden's "Oh, Give thanks" Giveaways; DPIE on sidewalks not yet conveyed to the city of Glenarden; Maryland-National Capital Park Police (Glenarden Municipal center sickle cell, cancer awareness, testing/blood drive dates).
  - c. Based on October Council consensus, contacted G.S. Proctor & Associates relative to willingness to negotiate the payments relative to the service provided. (Separate email sent to City Council)
  - d. See Code Enforcers reporting- DPIE ePlan Approved for 108-2020-0 Demolition of the Martin Luther King Site. Work can begin soonest with the demolition scheduling, expect an updated asbestos and other hazards survey will need to be accomplished due to the time lapse since last inspection/survey; *see also reference* R-24-2019 Resolution Authorizing Acceptance of Grant for MLK Park



e. Shared information on GOCCP State Aid for Police Protection Grant is the major annual funding source for the City's police department with A/Chief Jackson.

- f. Reviewed the Web/Media Specialist RFP draft submission / duty requirements sent to City Attorney to conduct actions towards securing a part-time Television Studio Manager.
- g. Update Prince George's County Department of Aging- Glenarden nutrition Center. COVID-19 left the department without many supporters coming back due to concerns relative to the spread of the virus. The department has communicated that it'd be reconsidering the various locations now closed for the future, but due to limited staff they are restricting the locations to those where the most attendance were formerly. Though there are many churches and other organizations which provide food services and Mayor Cross and the administration is looking into these for supporting the seniors as before.
- h. Supported as keynote speaker for the American Legion Post 275 and City of Glenarden Veteran's Day service. The event culminated at Glenarden after an 0800 am start - to deliver veterans memorial wreath to four of our District 24 neighboring cities as well Proclamations from Governor Lawrence Joseph Hogan Jr. Those cities included: District Heights, Capitol Heights, Fairmount Heights, Seat Pleasant, and Glenarden. The theme for Veterans Day November 11, 2021, was centered on the centennial commemoration of the Tomb of the Unknown Soldier. Located at Arlington National Cemetery, the Tomb was initially dedicated by the Army on Armistice Day, November 11, 1921, with the burial of an unknown service member from World War I – now serves to honor all service to all wars.
- i. City of Glenarden "Oh Give Thanks" Thanksgiving Community Outreach. This year's give away we expected to only support 50-but we were blessed triple fold to receive nearly 300 food boxes, turkeys, and 50- cash gift cards in time for Thanksgiving! Mayor's sending some huge thanks going out to the City of Glenarden Public Works, police and administration attending councilmembers, Reverend Belynda Gentry at First Baptist Church of Glenarden, (F.R.E.S.H) Fully Restoring Every Sons Hope, Shattered Ceilings, Prince George's Stand and Deliver, American Legion and American Legion Axillary Post 275, Citizen Jessie Huff, and Christopher Stevenson for their tremendous support. This was a huge lift and many great words received on the effort and service provided-exceptionally successful.
- j. The City of Glenarden's Polar Express scheduled for December 18 from 10 am-2 pm. At the Glenarden Municipal Center. The expectation - watch the Polar Express movie, service snack, popcorn, dance party, photos and gingerbread house, arts and crafts, and major giveaways for the kids from (Shattering ceilings, and FRESH, American Legion Post 275 joining effort with the City of Glenarden) Santa and his Elf visit and two super prize giveaways. The event is already getting calls from additional supporters' vendors wishing to donate to its success. Expectation 100-150 kids.

BVowie, MD addressing a rather large list of diminished sidewalk conditions/accesses along Hayes Street and Johnson Avenue, Johnson Avenue from Martin Luther King Jr Highway (MD704) to Hayes Street, additional ADA ramps/ hazards along Glenarden Parkway and Brightseat Road, Dellwood to Glenarden parkway, and Jeff Road to ensure proper sidewalk access point for residents. Proposal to add all repair necessary locations and then prepare smaller list off this approved listing to get taken care of. *(See the sample listing of sidewalks and cost to repair each)*

Maryland Citizens Redistricting Commission Approves Final Proposed Draft Map after conducting 39 virtual public hearings, including a Public Hearing on CR-123-2021, the Council's Redistricting Plan. In keeping with the County Charter, the Council heard public testimony on Tuesday, as it considered CR-123-2021, the Council's Redistricting Plan, and the Redistricting Commission's Proposed Plan. At the conclusion of the five-hour hearing 16 November evening, the Council voted 6-3 to adopt CR-123-2021.

The Prince George's County Housing Opportunities for All Work Group (HOFA) established by CR-16-2019, and co-chaired by Council Member Dannielle Glaros and, the Director of the County's Department of Housing and Community Development, Aspasia Xypolia, met virtually on Friday, November 19th. The HOFA Work Group is charged with developing policies and strategies to address the County's housing affordability, housing quality, and types. During Friday's meeting, HOFA members worked to achieve agreement on priorities for household income and location to shape detailed housing production targets, and to achieve a shared understanding of a permanent housing advisory group for the County. The next HOFA meeting is scheduled for December 17, 2021, at 10:30 AM.
- d. The Prince George's County Police Department is partnering with the faith community to host a gun turn-in program this Saturday, November 20TH, from 10:00 a.m. to 1:00 p.m., at the First Baptist Church of Glenarden. Residents can turn in guns anonymously, no questions asked, and receive free gift cards. Please take advantage of this opportunity to help get guns off our streets and create safer communities.

- e. President Biden has signed the bipartisan infrastructure bill passed by Congress. This bill represents the most comprehensive investment in infrastructure the nation has seen since the 1950s. This is great news for the state of Maryland and more importantly, for Prince George's County! Early estimates indicate that Maryland will receive at least:
  - i. \$4.1 billion for highway improvement
  - ii. \$1.7 billion towards public transportation
  - iii. \$844 million to improve water infrastructure, so residents have access to clean drinking water, no matter where they live
  - iv. \$409 million for bridge repairs and replacement
  - v. \$158 million to improve Maryland's airports
  - vi. At least \$100 million to expand rural broadband and bring internet to families who do not yet have access

vii. \$63 million to enhance and create more electric vehicle charging stations The headline number is \$1.2 trillion, the bill will provide about \$550B in new spending over the next decade, since some of the expenditures in the measure were already planned by the federal government. The bill passed with the support of most congressional Democrats, but also 13 House Republicans and 19 Republican senators. Much funding is up for grabs. The bill provides \$110B for road and bridgework, \$65B for electric grid improvements and a similar amount for broadband internet expansion, which stands to benefit the data center industry. It also includes \$66B for Amtrak expansion and billions more for upgrading water systems, mass transit, airports and seaports, and other projects.

- Oct. 23rd Glenarden police provided extra police presence for the Expungement Event by assisting with vehicular traffic and participants entering the Gold Room.
- Oct. 30th Glenarden police were assigned to coordinate traffic control for the Shred Day Event on the parking lot of the Municipal building.
- Oct. 30<sup>th</sup> Glenarden police hosted our "First Trunk or Treat "on the Municipal building parking lot from 4PM 5:30PM. Sargent coordinated this event with the vendor's and administrative staff; the event was very well attended with the council members and mayor showing their support.
- Nov. 2nd Sent out notification to all Glenarden city officials advising them of GPD officers responding to the area of the Hayes Street and Johnson Avenue for the sounds of "shots fired". Responding officers didn't find any noticeable evidence while on the scene.
- Nov. 3<sup>rd</sup> Resident called Glenarden police to report her parked vehicle (Hayes Street) had been damaged by two bullet holes (driver & passenger doors); no other calls for damaged vehicles.

#### **MLK DEMOLITION PROJECT:**

Spoke with Charles P. Johnson to update the finalization of revision requested by DPIE once the application was changed over to me becoming the point of contact. I also gave Charles P. Johnson access which they had before the revision request to the application so that they would be able to submit any additional updates needed to complete the revision. There was a fee involved to revise the original application which has been paid in order to start the revisions process. Upon payment and revision there is a two week turn around to review and approve the permit, this is the second week.

**UPDATE:** DPIE has approved the permit (108-2020-00) to demo the MLK Recreation Center 7921 Piedmont Ave. I have updated Gryphon and CPJ. Gryphon will bring in the equipment as soon as they receive payment so that he can fund the movement of equipment and personnel. I have informed the City Manager and Finance of the progress so we can expedite the funding of the demolition project. P.O. has been submitted for amount of \$15,000.00.

#### TREE TRIMMING AND ABANDONED VEHICLES:

Addressing the 8600 block of McLain Ave for several complaints of over growth and debris gathering, I went to the area of complaint to view the issue and agree with the complaint. I researched the property and found that it is property that belongs to the City of Glenarden. I then spoke with Public Works who stated that additional equipment will be needed which they currently do not have. To address the additional equipment Public Works are in the process of obtaining three bids to get an estimate of the work to be performed. **UPDATE:** I went to the 8600 block of McLain Ave to address a complaint of

abandoned vehicles with four flat tires. I spoke to one of the vehicle owner of the pickup with the mattresses on it he will take care of that this weekend as well as update the stickers on the registration that he has already received a citation for. To be clear, there are no vehicles on the City of Glenarden roadways with four flat tires. Officer Thompson and I can confirm that for the McLain Ave complaint. The City is patrolled in its entirety every day by the Police and Code Enforcement and a vehicle fitting that description would never be allowed to linger from day to day, let alone four years. There may be a case where someone is waiting for the insurance company to come give an estimate for damages due to an accident or vandalism but not for four years. In the future this type of complaint can be sent straight to Code Enforcement with a phone call and or in person on a daily basis with a prompt investigation into the matter.

#### HAYES ST. PARK /CITY PROPERTY

The Hayes St. Park and City property complaint at the corner of Hayes St and Johnson Avenue is still in the works. Due to thick brush, Public Works manpower as well as the removal of the debris from the City to the dump is all time consuming. Equipment is part of the issue; blades for the saws need constant sharpening or replacement. Though this complaint is a priority, the City still has to be maintained so as to not receive complaints from the residents. To date what is considered to be City property complaint has been addressed. All that is left is to finalize the permanent removal of the bamboo and its possible regrowth.

#### STORM WATER DRAINAGE PROJECT: FROST HOA, HOBBLEBUSH CT.

Since the beginning of this project County approval I have monitored the work being performed and its impact on the residence and local utilities. To date the issue has been equipment staging and parking. The Special One Day Permit from County is a one day, day to day and is ongoing until completion of the project which is meant to tie into the County drainage system while replacing older pipes with larger PVC pipes for the purpose of moving a higher volume of storm water from point to point, which residential to County spill.

#### **PUBLIC NUISANCE:**

Property belonging to an elderly resident that has extreme over growth in his back yard will be addressed once the contractor that will perform the work gets back from vacation.

#### **EQUIPMENT/ TECHNOLOGY:**

The Police Department and Code Enforcement really need to obtain equipment that will allow us to process a citation faster through software driven application on a cell phone which is connected to a handheld Bluetooth printer. The same software will be loaded to a desktop PC for tracking, voids, photos and time retention. The technology exists.

#### **COLLECTION AGENCY/ CONTRACT:**

I recommend that we enter into a contract with a Collection Agency to assist with the collection of collateral that people are refusing to pay for citations issued. To date we have a four to five inch high stack of unpaid citations that has not and will not be paid. Without the ability to collect or penalize people who refuse to pay is a waste of time, paper and man power, notwithstanding lost revenue. We stand to lose nothing from this process should a citation go into collection. We only lose when they pay with in the time allotted, as it stands their not because as it stands we're not.
