# Mayor Report (March 2023) Key Highlights Rollup

Mayor Cashenna A. Cross Report (Feb 27, 2023 - March 27, 2023)

- 1. Accomplished:
  - a. Resolutions/Council Actions:
    - Met with Councilmen (Herring and Hairston) and Heather McComas from the Crown Castle team evolution of 5G Glenarden Wards I and II identified cellular receptivity improvement zones.
    - ii. O-05-2023 An Ordinance to Amend Chapter 16 Ethics and Letter, signed and coordinated. The Maryland General Assembly enacted House Bill 363 and House Bill 1058 during the 2021 legislative session, which added new laws to the Maryland Public Ethics Law and requires local governments to incorporate certain changes into their respective ethics ordinances.
  - b. Annual Budget relative to the Executive branch for FY24 submitted. Treasurer compiling the overall budget submissions for public briefing. PG County Office of Finance, deadline for submitting the tax rates for billing met. Feedback sent to SDAT by May 26, 2023 deadline.
- The Mayor's Office has been extremely full of activity supported/fielded 18 office calls/meetings.
  - i. Ground breaking of Phase III\_ Pennrose, Redevelopment Authority of Prince George's County, B&W Solutions, & SHABACH! Ministries and the City of Glenarden development Glenarden Hills Phase 3 affordable living. This new March 15<sup>th</sup>, 2023 breaking set to bring the total units in Glenarden to 158. Glenarden Phase 3 is structured as a twin deal, meaning it is composed of two distinct projects, a 44-unit project financed with 9% tax credits titled "Glenarden Hills Phase 3, 9%", the other a 114-unit project financed with 4% tax credits appropriately named "Glenarden Hills Phase 3, 4%". In total, the Glenarden Hills Phase 3 projects will result in a combined 158-units once both projects are complete. The two phase 3 projects are the final rental phases of the Glenarden Redevelopment, which includes 424 units of new affordable, workforce and market rate multifamily housing and homeownership units targeted to seniors and families. The redevelopment replaces the original 578unit distressed Glenarden Apartments complex and is set to greatly accelerate the economic revitalization of a legacy City in Prince George's County. The overall Glenarden Hills project represents a \$110+ million investment in Prince

- George's County and brings a unique approach to delivering high-quality, mixed-income housing serving a diverse mix of households.
- ii. Prince George's Hope in Action Task Force and the Hope Collective. Mayor Cross serves on the Hope in Action Task Force selected by County Executive Alsobrooks as the Chairman for the Community Assessment Committee. Ten areas of community concern are being developed to address the ongoing disenfranchisement of youth across Prince George's County of these ten, five short wins are being recommended to grow county efforts immediately. https://www.princegeorgescountymd.gov/4308/Hope-in-Action
- iii. Met with Governor Wes Moore Intergovernmental Liaison. Work ongoing to secure access for our cities to various Pilot Programs Planning Grants and Capital Construction project inclusion in and around our city.
