Kathleen Guilliam-Delmar offered that Glenarden Housing is in need of gifts for the elderly and children this year; and that Glenarden Housing area needs more security cameras on the property. Also, stated she feels that the Mayor has not been engaged in the Council meetings.

Richard Arroyo-Montgomery commended the Council for a civil meeting. Also spoke toward the inactivity from Mayor Estes, but does not agree on a censure against the Mayor.

Ricky Thomas commended Mr. Bratton for the execution of the hazard pay to the essential workers.

Erika Fareed echoed the meeting tonight being civil. And also wants to see more parallel project planning on current and upcoming projects; such as the creation of volunteer Election Board members for the City. Suggested a list serve being created to incorporate all citizens in Glenarden.

Councilwoman Jones offers that if any citizens want to volunteer for the election board, to contact the Administration Department's Executive Assistant.

Leo Wilson, Sr. stated that the Mayor has not offered his reports in months and that he needs to be sanctioned.

Erika Fareed suggested that censuring of the Mayor does not help the situation and the Mayor and Council need to work together and move forward.



Ricky Thomas offered that everyone needs to approach each other with respect.

Derek Curtis offered he is a Woodmore Resident, which is a part of the City of Glenarden and there should not be any separation.

Richard Arroya-Montgomery offered that he is a Woodmore resident but he is being verbally attacked by ward one residents.
