- **J. Herring** – Councilman Herring requests a budget tracking spreadsheet itemizing each departments projected budget for their approved events.

- **R. Jones** – Request to hold the increase on the City Managers salary until the six-month evaluation period has been completed as satisfactory.
- **J. Herring** – Requests a 5k increase on the budget line for the Glenarden Day Event considering the recent inflation on food and gas and lack of local retailer support and donations towards the event.
- **President Curtis** – Remove the 87k salary bonus from being spread out amongst the departments by head count and place the surplus in General Funds under Bonus and Salary Adjustments as a lump sum and add 50k to that line item. A plan needs to be developed for employee distribution.
