

## CITY OF QUINCY IN COUNCIL

ORDER NO. 2023-006

ORDERED: January 30, 2023

That the City of Quincy appropriate the amount of One Hundred Fifty Thousand (\$150,000.00) Dollars for the purpose of paying costs of the feasibility study/schematic design relating to the replacement of the boilers at the F.W. Parker Elementary School and sections of the roofs at the Montclair and Wollaston Elementary Schools, including the payment of all costs incidental or related thereto, and for which the City of Quincy may be eligible for a grant from the Massachusetts School Building Authority ("MSBA"), said amount to be expended under the direction of Department of Public Buildings.

To meet this appropriation, the Quincy City Council, with the approval of the Mayor Thomas P. Koch, shall charge Fiscal Year 2024 Revenue.

The City of Quincy acknowledges that the MSBA's grant program is a non-entitlement, discretionary program based on need, as determined by the MSBA, and any costs the City of Quincy incurs in excess of any grant approved by and received from the MSBA shall be the sole responsibility of the City of Quincy and that the amount of appropriation authorized pursuant to this vote shall be reduced by any grant amount set forth in the Project Funding Agreement that may be executed between the City of Quincy and the MSBA.

# Community Liaison Position & Equity and Inclusion Commission Update

**WHEREAS,** the Administration in June of 2022 approved money to pay a \$75,288 salary of a Community Liaison position within the Mayor's office; and

**WHEREAS,** the Mayor named and established a 9-person Equity and Inclusion Commission to examine the city's practices and culture to make recommendations on how to welcome and involve all in the city; and

WHEREAS, as reported in the Patriot Ledger on June 1, 2022 it appears that commission outlined goals and primary recommendations; and

**WHEREAS,** the Equity and Inclusion Commission is not listed on the Board & Commissions webpage where citizens can find agendas and minutes of other Boards and Commissions; and

**WHEREAS,** the City Council unanimously approved the Mayor's budget including the new Community Liaison after requesting a Department of Social Justice and Equity in January of 2022 and January 2021; and

**WHEREAS,** there have been multiple racial incidents in Quincy that have appeared in the media.

**THEREFORE LET IT BE RESOLVED,** that the Quincy City Council requests that the Administration provide an update to the City Council on the status of filling the Community Liaison position and the Equity and Inclusion Commission's recommendations.
