BE IT ORDAINED by the City Council of the City of Quincy that the official salary schedules of the City of Quincy, as referenced in Chapter 72, Article I, § 72-1, as amended (originally adopted as Ch. 2.148 of the 1993 Quincy Municipal Code) is hereby further amended by deleting the current salary of the Mayor and inserting the following:

<i>Mayor</i>	<i>\$285,000.00</i>

The salary shall become effective January 1, 2025
