**RESOLUTION NO. 21-20**

**A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN  
INTERLOCAL AGREEMENT BETWEEN ROY CITY AND WEBER SCHOOL  
DISTRICT FOR USE AND MAINTENANCE OF THE ROY JUNIOR HIGH SCHOOL  
GYMNASIUM**

**WHEREAS**, Roy City desires to use Weber School Districts Roy Junior High School Gymnasium for Roy City Recreation programs; and

**WHEREAS**, The Weber School District desires to allow Roy City to use the Gymnasium for its recreation programs; and

**WHEREAS**, under the Utah Interlocal Co-operation Act UC 11-13-1, et seq., Utah Code Ann., 1953, as amended, (the "Act"), any power or powers, privileges or authority exercised or capable of exercise by a public agency of the state may be exercised and enjoyed jointly with any other public agency, and that any two or more public agencies may contract with one another for joint or cooperative action under the Act; and

**WHEREAS**, the Roy City Council finds that it is in the best interest of the citizen of Roy City to enter into the Interlocal Agreement that is attached hereto for the provision of their mutually beneficial services; and

**NOW THEREFORE**, be it resolved by the Roy City Council that:

1. The attached Interlocal Agreement between the Weber School District and Roy City for the use and maintenance of the Roy Junior High School Gymnasium is hereby approved and the Mayor is authorized to execute the agreement effective this \_\_\_ day of September, 2021.
