

Executive Summary

As discussed in the last city council meeting, the Recreation Complex revenues and expenditures have been evaluated and need to be adjusted at this time to complete the renovation project.

General Fund -

The following expenditures need to be adjusted in the FY2024 budget:

- Decrease part time wages by \$204,000.
- Decrease operations and maintenance expenses by \$162,100.
- Increase capital expenses for the renovation by \$1,110,000.

The following revenues need to be adjusted in the FY2024 budget:

- Increase complex donations received by \$22,550 for donations received since June 2023.
- Increase RAMP grant revenue by \$21,000 to apply the per capita grant received this year to the renovation project.
- Decrease complex revenue by \$206,000 for the period the facility was closed this fiscal year.
- Increase use of fund balance by \$906,350 to complete the remaining renovation project.

Recommendation

We recommend that the City Council approve the adjustments as shown above. Resolution No. 24-01 has been prepared for your consideration.

Fiscal Impact

The impact to the General Fund, overall, is an increase to revenues and expenditures of \$743,900.

WHEREAS, the proposed interlocal agreement delineating the relevant terms, conditions, and obligations of the parties is attached to this resolution as "Exhibit A"; and

WHEREAS, the City Council finds that entering into and supporting the interlocal agreement is in the best interest of the citizens of Roy City;

NOW THEREFORE, the Roy City Council hereby resolves to enter into the attached Interlocal Agreement with Hooper City for the purpose of providing crossing guard personnel. The Mayor of Roy City is authorized and directed to execute the Interlocal Agreement for and on behalf of Roy City.

INTERLOCAL COOPERATION AGREEMENT FOR CROSSING GUARD SERVICES

This Agreement, made and entered into this 7th day of December, 2023, pursuant to the provisions of the Interlocal Cooperation Act (Section 11-13-101, et. Seq Utah Code Annotated 1953, as amended) by and between Hooper City, a Utah Municipal Corporation, and Roy City, a Utah Municipal Corporation.

WITNESSETH

Whereas, Hooper City and Roy City have determined there is a need to formalize an agreement for the provision of crossing guard services for Hooper City; and

Whereas, Hooper City desires to obtain crossing guard services at its elementary schools; and

Whereas, Roy City through the Roy City Police Department has the ability to provide such services.

Now, therefore, upon the mutual promises, and other good and satisfactory consideration, the parties agree as follows:

For the 2023 – 2024 school year Roy City will provide five crossing guards for crossing assistance in Hooper City. Three crossing guards for Hooper Elementary School, one for Freedom Elementary School and one crossing guard at the intersection of 4800 South 4700 West for Hooper City students going to Country View Elementary.

The crossing guards will each work 3 hours for every day school is in session, one hour each for morning, midday and afternoon crossing times.

The crossing guards are Roy City employees and will continue to be compensated, trained and supervised by the Roy City Police Department.

In consideration for Roy City providing crossing guards, Hooper City will pay Roy City \$44,591.99 in quarterly installments of \$11,148.02 for Quarter 1, and \$11,147.99 for Quarter 2 through Quarter 4,

Cost of living adjustments as determined by Roy City are acceptable.

This agreement shall continue until terminated by either party upon 30 day written notice.

No separate legal or administrative entity is created by this Agreement.

Each City shall be responsible for all damages to persons or property that occur as a result of the negligence or fault of that City's employees in connection with the performance of this Agreement. The responsible City shall also defend and indemnify the other City for all claims and expenses that arise out of the performance of this agreement. However, in no event shall indemnification exceed the amount set forth in Utah Code Annotated 63G-7-604.

This Agreement shall not be modified or amended, except in writing, and before any amendment is effective it shall be signed by the duly authorized representative of each of the parties after the adoption of a resolution of each entity approving the modification or amendment.

This Agreement is made and entered into subject to the provisions of the laws of the State of Utah, which laws shall control the enforcement of this Agreement.

This Agreement shall constitute the entire Agreement between Roy City and Hooper City and any prior understanding or representation of any proceeding the date of this Agreement shall not be

binding upon either party except to the extent incorporated in this Agreement.

This Agreement shall not be effective until approved by a resolution of the Roy City Council and the Hooper City Council, in accordance with the provisions of Section 11-13-202.5, Utah Code Annotated, 1953, as amended, and submitted to and approved by an authorized attorney for each party who shall approve the Agreement as being proper as to form and compatible with the laws of the State of Utah.

An Ordinance of Roy City Adopting an Ordinance Regulating Camping Activities and Amending Roy City Code 5-2-4 Park Curfew establishing Rules for all Roy City Parks and Trails; and by Providing That This Ordinance Shall Become Effective Immediately Upon Posting After Final Passage.

WHEREAS, the Roy City Council exercises its legislative powers through ordinance; and

WHEREAS, there is not currently a Roy City Ordinance regulating camping activities on public property; and

WHEREAS, City Park and Trail rules only address park curfew and there are several areas not addressed that affect the enjoyment of City Parks and Trails; and

WHEREAS, the City Council has determined that adopting these updated codes is in the best interest and protects the health, safety, convenience, and general welfare of the citizens of Roy;

NOW THEREFORE, be it ordained by the Roy City Council as follows:

Title 5 of the Roy City Municipal Code is hereby amended by adopting and updating the following chapters and sections of Title 5 of the Roy City Code:

Chapter 2

Crimes and Offenses

SECTION 4:

5-2-4: Parks Curfew

City parks shall not be open to the public during the hours of eleven o'clock (11:00) P.M. to six o'clock (6:00) A.M. and it shall be unlawful for any person to enter or be upon any city park between the hours of eleven o'clock (11:00) P.M. and six o'clock (6:00) A.M., except where otherwise posted by Roy City or when participating in or attending an activity sponsored by the eity or allowed under a permit issued by the city, and except for persons directly crossing or passing through a park on a regularly established walkway. A park curfew violation is a class C misdemeanor.

5-2-4(1) Statement of Purpose

The provisions of this Chapter are to preserve the public parks and grounds for the enjoyment of all, to ensure that all individuals shall be able to enjoy public parks and grounds, to encourage compatible activities in appropriate areas, to promote the safety and welfare of the public, and to enforce the rules and regulations adopted by Roy City.

5-2-4(2) Parks & Trails Defined

Refers to all city-owned or operated property, referred to as parks, and any improved or unimproved trails or open spaces, golf courses, playgrounds, shelters, restrooms, ponds, indoor/outdoor facilities, athletic fields, cemeteries, courts, dog parks, and walking trails within the boundary of Roy City. "Parks" include the entire site of the park, including, without limitations, all structures thereon, and any public parking lots in or adjacent to the park sites.

5-2-4(3) Park & Trail Hours

City parks & grounds shall not be open to the public during the hours of ten o'clock (10:00) P.M. to six o'clock (6:00) A.M. and it shall be unlawful for any person to enter or be upon any city park between the hours of ten o'clock (10:00) P.M. and six o'clock (6:00) A.M., except where otherwise posted by Roy City or when participating in or attending an activity sponsored by the city or allowed under a permit issued by the city.

5-2-4(4) Parking & Vehicle Use Restrictions

- (A) It shall be unlawful to park any vehicles within the park property in such a way as to block the roads or pedestrian paths provided for public traffic.
- (B) It shall be unlawful to drive any motorized vehicle or to allow any motorized vehicle to proceed on or over any garden, lawn, sidewalk, or any other portion of a city park which is not specifically designated for the use of a motorized vehicle, except with written permission from the Parks and Recreation Director or their designee, and/or Roy City personnel and vehicles for park maintenance or other functions conducted by Roy City personnel essential for the wellbeing of the city.

(C) OVERNIGHT PARKING

- Not permitted in a city park during curfew hours;
- The registered owner of any vehicle parked in violation of any of the provisions of this ordinance shall be prima facie responsible for such violation and subject to the penalty.

(D) PENALTY

 Violation of any parking & vehicle use provision is punishable by issuance of a Roy City citation and subject to removal and impoundment by a police officer of the City at the registered owner's expense.

5-2-4(5) Park Rules

To provide for the safety and enjoyment of all visitors, the following items and/or activities are prohibited in Roy City Parks:

(A) ARCHERY:

i. Using public park areas for archery is prohibited.

(B) CONCESSIONS/VENDORS:

i. No person may sell food, drinks, or other items in the park, except as may be permitted by city contract.

(C) DOGS:

i. Dogs must remain on-leash and be under the handler's direct control at all times. Exception to on-leash is at specified dog park areas.

(D) FIRES:

i. Open fires, fire pits, etc. are prohibited in public parks.

(E) GLASS CONTAINERS:

i. Use of glass containers in public parks is prohibited.

(F) GOLFING:

i. Practicing, playing, or using public park areas for golf is prohibited.

(G) HORSES OR HORSEBACK RIDING:

i. Horses and/or horseback riding is prohibited in public parks, including park sidewalks and walking trials/paths.

(H) INFLATABLE STRUCTURES/DUNK MACHINES/ETC :

i. Inflatable structures or other similar devices are not allowed in city parks.

(I) METAL DETECTING:

i. Use of metal detectors and associated tools is prohibited.

(J) SKATEBOARDS/SKATES/SCOOTERS/ETC:

- i. Skateboards, rollerblades, scooters, bicycles, or similar devices are not allowed on park sport courts.
- ii. Skateboards, rollerblades, scooters, bicycles, or similar devices must remain on park sidewalks, paved trials, or areas specifically designated for such use.

(K) SMOKING

- i. Smoking means:
 - a. The possession of any lighted or heated tobacco product in any form;
 - b. Inhaling, exhaling, burning, or heating a substance containing tobacco or nicotine intended for inhalation through a cigar, cigarette, pipe, or hookah; or
 - c. Use of an e-cigarette

(L) SPORT COURTS/SPECIFIED AREAS:

i. Designated areas will only be used for the designated activity. Pickleball courts, tennis courts, basketball courts, etc.

All City, County, State, and Federal laws and ordinances must be followed and will be enforced by the Roy City Police Department.

Any exceptions or special permissions to these rules and restrictions must be through an approved Roy City special event permit.

- 5-2-4(6) Penalties
 - (A) A person violating any of the provisions of this chapter may be trespassed from all Roy City Parks and Trails.
 - (B) Roy City reserves the right to have any person removed and/or trespassed from a park/parks for violation of a city ordinance. Upon observing, or becoming aware of violation, a Roy City Police Officer shall have the authority to have the offender/offenders removed from the park for the remainder of the day. For a trespass that exceeds 24 hours, the Parks & Recreation Director or their designee shall be awarded the authority to determine the length of time the offender is trespassed from parks. Determining factors will consist of the severity of violation, previous violations, and the citizens interest in being able to safely enjoy their parks.
 - (C) Roy City code 5-2-4 establishes the general guidelines adopted by all city properties identified as being a park. Additional rules and hours may exist based on the needs of the specific area, i.e., splash pad, aquatic center, pond. Additional rules and hours will be posted on those grounds and are expected to be followed as described.

SECTION 9: CAMPING

5-2-9(1) Camping and Related Activities

It is unlawful for any person to camp, lodge, sleep, cook, make a fire or pitch a tent, fly, lean to, tarpaulin, umbrella, or any other type of ground cover or shelter, or place sleeping bags, bedding or any other type of camping or sleeping equipment upon any portion of a public way, as defined herein, and it is unlawful for any person using or benefiting from the use of any of the foregoing shelter or camping or sleeping equipment to fail to remove the same from any such street or public way.

5-2-9(2) Definitions

Public way "public place", as used in this section means:

- a. Any public street, sidewalk, alley, or right of way;
- b. Any city park as defined in 5-2-4(2)
- c. Any publicly owned building or publicly owned real property;
- d. Any outdoor public area on the premises of a commercial or manufacturing building, except with the permission of the owner or lawful possessor of the property;
- e. Boarded, vacant, or abandoned buildings; or

f. Vacant lots within Roy City.

5-2-9(3) Penalty

Violation of the city camping ordinance is a class C misdemeanor, with a possible punishment of up to 90 days in jail and up to \$750 in fines, per occurrence.

CAMPING AND RELATED ACTIVITIES:

• It is unlawful for any person to camp, lodge, sleep, cook, make a fire or pitch a tent, fly, lean to, tarpaulin, umbrella, or any other type of ground cover or shelter, or place sleeping bags, bedding or any other type of camping or sleeping equipment upon any portion of a public way, as defined herein, and it is unlawful for any person using or benefiting from the use of any of the foregoing shelter or camping or sleeping equipment to fail to remove the same from any such street or public way.

- f. Vacant lots within Roy City.

PENALTY

Violation of the city camping ordinance is a class C misdemeanor, with a possible punishment of up to 90 days in jail and up to \$750 in fines, per occurrence.

Roy City Municipal Code 5-2-4 Park Curfew

Proposed changes

City parks improve our physical and psychological health, strengthen our community, and make our city and neighborhoods more attractive places to live and work. A "safe park" is one with clear, established rules enforced for the benefit of the community and its members. Clear established park rules demonstrate a city's commitment to the continuous efforts required to make city parks a priority. In contrast, a city's absence of park rules and relevant park signage gives a perception that parks are not a priority, and as a result, invite additional property damage, vandalism, and disruptive behavior decreasing community use and trust.

A basic component of park safety is park rules. Roy City is in desperate need of a municipal code specific to parks, one that clearly states procedures and provides Roy City Police Officers with the support and direction needed to enforce those rules in order to fulfill our obligation to the community.

Current city code 5-2-4 (only code regarding parks)

City parks shall not be open to the public during the hours of eleven o'clock (11:00) P.M. to six o'clock (6:00) A.M. and it shall be unlawful for any person to enter or be upon any city park between the hours of eleven o'clock (11:00) P.M. and six o'clock (6:00) A.M., except where otherwise posted by Roy City or when participating in or attending an activity sponsored by the city or allowed under a permit issued by the city, and except for persons directly crossing or passing through a park on a regularly established walkway. A park curfew violation is a class C misdemeanor.

Current code issues

No definitions of a park (biking path is not included) No parking restrictions (overnight parking) No rules for park conduct No penalties for violation of park conduct No authority to enforce park conduct. Posted signs old, outdated, and only in limited locations.

This letter is to inform you that as of June 30, 2024, Weber Human Services Area Agency on Aging will terminate the existing *Interlocal Cooperation Agreement* between Weber Human Services and your city.

This termination notice is being delivered to all the Cities that have similar contracts. The purpose of doing this is to review and evaluate the general funding support by Weber Human Services of senior center activities within Weber County by July 1st, 2024. We anticipate that new contracts will be developed prior to this date based on the evaluation of needs for these services.
