Meeting called to order:

The Somerset County Board of Elections meeting was called to order by Board President Ernest Satchell on June 2, 2025 at 10:06 am, members established a quorum. Clarice Mathies, Board Secretary led us in prayer and all present recited the Pledge of Allegiance.

Minutes:

Minutes of the March 3, 2024 meeting were read silently. Motion by Stephen Flaherty to accept the minutes as written, April Tyler seconded and the motion was carried.

New Business:

Open Meetings Act

Kristen Gilbert asked the Board President Ernest Satchel to give a summary of the opinion of the State of Maryland Compliance Board on the Somerset County Board of Elections. Ernest Satchel

asked Clarice Mathies, Board Secretary to give the summary. The Open Meeting Compliance Board issued an opinion finding the Somerset County Board of Elections in violation of the Open Meeting Act by failing to post meeting agendas and minutes online. The State did commend the Board for establishing a plan, moving forward, that will permit Board staff to post meeting agendas and minutes online without needing to go through the County's information technology department.

Julia Cox, Director stated that the Elections office has corrected the violations' issue and will continue to post online in the future.

Election Director and Program Supervisor Reports

Brenda Powell gave her Election Supervisor 1 report. Brenda Powell gave each member the updated numbers that were processed thru MDVoters for March through May 31st of 2025. Save the date cards are completed and are to be mailed to Election Judges. Letters of Intent are completed and to be mailed to Election Judges. A tentative training schedule was given to begin in September 2025. Updated forms for Election Judge Recruitment are done. Training manual updates from the state for virtual meetings. Training Curriculum packets organization has started. The Election office will set up a booth at the Somerset County Fair on July 25-26, 2025 to register persons to vote or make changes to existing voter registration information and to recruit new election judges. The Board was given sample Election Judge application.

Julia Cox gave her Director's Report: We do not have an IT person yet; Brenda Powell and Heather Insley were trained on PEM (Post Election Maintenance) by IT personnel from Talbot and Worcester County. They completed the maintenance for the Pollbooks through the first week in March.

Brenda Powell and Heather Insley were also trained on the PEM for DS200's and BMD's by various IT persons from Talbot, Wicomico, Worcester, and Lynnette Cottman-our election support and Paul Nornbrook SBE Regional Manager.

The gym was secured for all the equipment. Brenda and Heather cleaned and organized the warehouse which was a huge undertaking. On April 30th, 2025, Brenda, Heather, and Lynnette started the inventory of the equipment and moved all equipment and carts back into the warehouse.

With the help of the County IT Brenda set up our website and is maintaining it until our IT position is filled. Brenda has also set up the Youtube for the meeting site.

The interview process for a new IT person begins on June 9, 2025.

Julia Cox handed out the Gubernatorial Election Calendar.

Joy Hall asked if you had already completed a Direct deposit form does it have to be done again
Julia Cox responded- No.

Board President Ernest Satchel noted that there were no public present for comment.

Ernest Satchel asked for a motion to end our regular session meeting and a motion to go into closed session. Motion made by Joy Hall and 2nd by April Tyler.

Motion was made to go into closed session at 10:16. Motion was made by Joy Hall and seconded by April Tyler. All were in favor, motion carried.
