# 8A. PUBLIC HEARING CONSIDERATION OF ROAD NAME CHANGE BLACKHEAD SIGNPOST ROAD

#### **OPENING STATEMENT**

This public hearing is held pursuant to Section 15.2-1427 and 15.2-2204 of the Code of Virginia, 1950, as amended, to consider a request initiated by the Board of Supervisors of Southampton County pursuant to Section 14-25 of the Southampton County Code to change the name of Blackhead Signpost Road. The aforementioned roadway is situated between Virginia Primary Route 35 (Meherrin Road) and Virginia Secondary Route 673 (Grays Shop Road) and located in the Boykins-Branchville Election District. Recommendations for a new road name will be received and considered at this hearing.

Following its public hearing on December 10, 2020, the Planning Commission recommended the following road names for the Board's consideration:

- 1. "Alfred Road," to honor the enslaved person which historical records indicate was the person who was the subject of the horrific incident;
- 2. "Big Pumpkin Road," a name suggested by a resident of the road who, along with her husband, grows Virginia State Fair prize winning pumpkins; and
- 3. "Millpond Road," the historical name of the road according to long-time County residents.

The notice of tonight's public hearing was published in the Tidewater News on January 6 and January 13, 2021 and all landowners along the roadway were notified by first class mail.

After conclusion of tonight's public hearing, the Board of Supervisors may adopt the attached resolution designating a new road name, or take the comments under advisement for later consideration. The effective date of any road name change shall be sixty (60) days following adoption of the resolution to provide adequate time to notify all affected parties.

Mrs. Beth Lewis, Secretary of the Planning Commission, will provide introductory remarks after which all interested parties are invited to come forward and express their views.

**ACTION REQUIRED:** 

A motion is required to either adopt the attached resolution designating a new road name, or take the comments under advisement for later consideration.

#### A Resolution Renaming Blackhead Signpost Road

WHEREAS, Section 15.2-2019 of the Code of Virginia provides statutory authority for every locality to name streets, roads and alleys within its respective boundaries; and

WHEREAS, the road names for all public roads in unincorporated areas of Southampton County were, following a public hearing, duly adopted by resolution of the Board of Supervisors on February 27, 1989; and

WHEREAS, the aforementioned resolution named a segment of Virginia Secondary Route 658, from Virginia Primary Route 35 (now known as "Meherrin Road") to Virginia Secondary Route 673 (now known as "Grays Shop Road,") as "Blackhead Signpost Road;" and

WHEREAS, in regular session on July 28, 2020, an organization named Citizens for Change, raised this Board's awareness while respectfully making known that the aforementioned road name is demeaning, derogatory, and offensive to a large number of residents in Southampton County, as well as to many county visitors, and requested this Board's cooperation and assistance in initiating name changes for "Blackhead Signpost Road," and

WHEREAS, Section 14-125 of the Southampton County Code provides that requests to change the names of existing streets may be initiated by resolution of the Board of Supervisors; and

WHEREAS, by resolution duly adopted on September 22, 2020, the Southampton County Board of Supervisors initiated a request to change the name of "Blackhead Signpost Road," and requested the Southampton County Planning Commission to conduct a public hearing and offer its recommendations for a new road name for "Blackhead Signpost Road;" and

WHEREAS, the Southampton County Planning Commission conducted its public hearing regarding this matter, following proper public notice, on December 10, 2020 and subsequently forwarded three recommendations to the Board of Supervisors including "Alfred Road," "Big Pumpkin Road," and "Millpond Road;" and

WHEREAS, the Board of Supervisors conducted its public hearing with regard to this matter, following proper public notice, on January 26, 2021 in order to receive additional comment and suggestions regarding appropriate road names.

NOW, THEREFORE, BE IT RESOLVED by the Board of Supervisors of Southampton County that:

- 1. The name "Blackhead Signpost Road" is hereby repealed;
- 2. The new road name for Virginia Secondary Route 658 (formerly "Blackhead Signpost Road,") from Virginia Primary Route 35 (now known as "Meherrin Road") to Virginia Secondary Route 673 (now known as "Grays Shop Road,") shall now be
- 3. This new road name shall take effect sixty (60) days following adoption of this resolution;
- 4. The County's Geographic Information System (GIS) shall be updated to reflect this change;

- 5. The Southampton County Sheriff's Office is hereby requested to replace all affected road name signs at each roadway intersection;
- 6. The owners of all improved properties affected by this road name change shall be promptly notified of their change of address by the County;
- 7. The County shall promptly notify the Clerk of the Circuit Court, the U.S. Postal Service, all major couriers, the Voter Registrar, all Fire Departments and Rescue Squads who respond to calls along this roadway, and each utility provider serving customers along this roadway.

RE: Public hearing regarding Blackhead Signpost Road

At their regular December 10, 2020, meeting, the Planning Commission held a public hearing regarding the Board of Supervisor's request to change the name of Blackhead Signpost Road. There were six (6) members in attendance.

Prior to the public hearing, the Planning Commission received 11 letters with regard to the name change, several of which included potential names. Of the 11 letters received, ten (10) were in favor of the change, while one (1) was in favor of retaining the name, "to tell what happened here, and to inform the public how history was affected by this event". The Board also heard from two (2) speakers from the community during the public hearing, both in favor of changing the name of the road. The Board made a motion to amend the name of the road, and the vote in favor was unanimous.

The Commission then discussed the potential names. After discussion and consideration, the Planning Commission made a motion to forward the following three (3) names, listed in alphabetical order:

- Alfred Road, to honor the enslaved person historical records indicate was the person who was the subject of the horrific incident;
- Big Pumpkin Road, a name suggested by a resident of the road who, along with her husband, grows Virginia State Fair prize winning pumpkins;
- o Millpond Road, the historical name of the road according to long-time County residents

The Board voted in favor of the list of potential road names 5-1. The dissenter wanted to make clear that he agreed with changing the name of the road, but feels naming the road after a person may lead to the need to reconsider the new name again in the future, as sentiments change.

Chairman Drake says we have a proper motion and a second for the request with the change mentioned, he ask is there any other discussion before we vote. He says, if not, I'll call for the vote. He says, all those in favor, say aye

Chairman Drake continues, any opposed, like sign.

Chairman Drake says the vote is unanimous and that will go forward at the January meeting to the Board of Supervisors as a favorable recommendation.

Chairman Drake says thank you all and thank you for coming tonight.

Mrs. Darden says, I hope we bring lots of revenue to Southampton County.

Chairman Drake says, yes, thank you. He says we look forward to you all opening and wish you the best of luck and we hope it turns out good for you.

Chairman Drake says next we are down to item D which is a request initiated by the Board of Supervisors about the road name change.

Chairman Drake says, Mrs. Lewis if you would like to proceed please.

Mrs. Lewis says that is correct. She says this is a request initiated by the Board of Supervisors of Southampton County to change the name of BlackHead Sign Post Road, the aforementioned road way is situated between Virginia Primary Route 35 which is Meherrin Road and Virginia Secondary Route 673, Grays Shop Road and is located in the Boykins-Branchville Electoral voting district.

She says recommendations for a new name will be received this evening as well. She says this was scheduled for last month's public hearing, the one that got rained out, so it got forwarded to this month. She says, I have received a total of eleven emails between the two months, you have all of them and you have the summary. She says there were ten in favor of and one opposed to the change. She says the suggested names are: one for Big Pumpkin Road, one suggested name was Millpond Road which is apparently the historical name of the road and six suggestions were for Alfred Road. She says you have copies of all the letters, they will be made part of the minutes, I asked Attorney Railey if they all had to be read into the minutes and he said no but they will be attached to the minutes and nine of the eleven were attached to your agenda that was on line because I received them in time. She says, I'm sure there are people here to speak this evening but that's all the information that I have. She says, thank you.

Chairman Drake says thank you. He asks are there any other comments before we proceed with the hearing. He says, if not, I will open the public hearing, if anyone would like to come forward to address the road name change in the Newsoms area. Please come forward.

Mrs. Lewis says, Mr. Drake if you will remind people to state their name and address for the record.

Michelle Covington comes forward.

Chairman Drake states thank you being here, if you will state your name for the record.

Ms. Covington says thank you for having me. She says my name is Michelle Covington and I am a member of Citizens for Change and I reside at 18199 Crosskeys Road in Boykins Virginia. Mrs. Covington read a prepared statement which will be made part of the minutes.

At the end of the presentation, Chairman Drake says thank you and asks are there any questions. He says, what a history lesson. Thank you very much.

Mrs. Lewis says Ms. Baker is the appropriate person to leave your notes with that will be very helpful. Thank you.

Chairman Drake ask would anyone else like to come forward, the public hearing is still open.

Mr. Travis Parker comes forward and says, Good evening, my name is Travis Parker and I live at 120 Rawlsdale Road, Franklin Virginia and I am a member of Citizens for Change and prior to being raised in Southampton County. He says this process has been long but I am proud to have been a part of it, of the changing of Blackhead Sign Post Road and I am proud of our governing body throughout this process that I've heard everyone, even though we may have had some disagreements with the ordinance, everybody (from what I heard) was in agreement that this road name needed to be changed. He says that since we are past the part of the ordinance, there was some disagreement but we are on the other side of that I feel that we are all in favor that the name needs to change. He says, I stand here this evening to let you know that I am in agreement with the name of the road becoming Alfred Road. He says along with Ms. Covington and the many e-mails that you have received. He says I truly believe that the Alfred Road, based on what you have just heard, Ms. Covington has given some good reasons why you this name should be changed to Alfred Road. He says, with that said, thank you for being a part of the process and for us to be able to right this wrong and I just ask you to recommend to the Board of Supervisors to change the name of Blackhead Signpost Road to Alfred Road.

He says, thank you, any questions.

Chairman Drake says thank you Mr. Parker and asks is there any questions for Mr. Parker.

Commissioner Randall says I've got one question. He says, in our packet (and I don't know if you have this) but we have an e-mail from a Billy Cole. He says that he was involved in the first go round,

(Commissioner Randall said there is information on the back of the page provided by Mrs. Lewis) he headed the road naming committee, I guess, back in 1988. He asks, do you have any information or knowledge about the road naming committee that Mr. Cole headed.

Mr. Parker says no I don't have any information about what went on prior.

Commissioner Randall says his historical was very similar to your presentation, the gentleman named Alfred, his historical perspective was spot on to what you asked us to do. He says, I was just wondering if he was a part of the research or we could kind of expand on his email.

Mr. Parker says I would like to ask Ms. Covington does that rings a bell with her, Ms. Covington did a lot of our research.

Ms. Covington asks what the name was again.

Chairman Drake says his name is Billy Cole and he is identifying himself as the person who headed the road naming committee and this occurred on or about 1988, that time frame.

Ms. Covington says I don't have any information about Mr. Cole but if you have contact information for him, I would love to talk with him but no I don't have any. She says you are saying that he is saying the same thing that we were saying.

Commissioner Randall says yes, he was giving kind of the historical, he wrote a letter to our county administrator basically recommending the name change and I'm sure Mrs. Lewis can give you a copy of this information and giving his name as Alfred and the name change. He says, it seems from the email, I don't want to speculate too much, that he was the head of some committee on the behalf of County to rename roads and I don't know procedural history behind that because it was so long ago, 1988, I wasn't a member of the Planning Commission. He says we can probably request that from Mr. Johnson but I was just wondering if he was part.

Mr. Chesson says that committee meet in 1987.

Ms. Covington says yes I am aware that there was a committee that named roads because they used to all be numbers but I was born in 1983 so I don't know what that process looks like but if there is a way to get in touch with someone who is a part of that process period, I would love to hear their opinion and talk to them.

Chairman Drake says thank you.

Ms. Covington says thank you.

Chairman Drake says are there any questions for Mr. Parker?

There being no, Chairman Drake says thank you both for coming.

Mrs. Lewis says I requested and received a list of all the road names in Southampton County from GIS to make sure that any names that were recommended weren't already in use or almost like that. She says there is no name like that and there is no name that is near Alfred Road, it goes from Agri Park Drive to Alley Street. She says we have a Cabin Pond and a Cabin Point and those are at different ends of the County but very similar names. So there isn't anything near Alfred Road.

Chairman Drake says anyone else like to come forward, the public hearing is still open. He says, if not I am going to close the public hearing and open the panel up for discussion.

Commissioner Randall says I would like to ask Dr. Edwards a question because this is the first one we have had, so is the Board asking for a recommendation of whether or not for a name change number one and then a possible change.

Mrs. Lewis says that is correct.

Commissioner Edwards says the Board is asked for a change.

Commissioner Randall says because the agenda, it's kind of ambiguous.

Mrs. Lewis says from their minutes, they are asking for two recommendations, one whether or not to change the name and then Mr. Johnson told me a list of three to five possible names would be all that they would need, they don't want you to come up with twenty names, but yes or no to change the name and three to five or however, a handful of possible names.

Commissioner Randall says I think from a historical perspective, for me it's a pretty easy choice. He says it seems that the concern is that the historical context, it was a slave named Alfred, I don't think that's disputed by anyone and I think that is the best evidence that's come forth. He says I spoke with Rick Francis about it and he's the Turner Rebellions' expert but I think all indicia and evidence points to that so that would be my recommendation, that we approve the name change and recommend to the Board of Supervisors that we change the name to Alfred Road.

Commissioner Chesson says, Mr. Chairman.

Chairman Drake acknowledges Commissioner Chesson.

Commissioner Chesson says I guess I will repeat what I have shared in an email, I would recommend looking in a different direction other than a person's name. He says reason being is that today we see Alfred as somebody that fought for a good cause and laid down his life, five years from now there might be another group of people that come along saying, what was the Board of Supervisors thinking to name this to keep us reminded of these horrible things that happened or it may come up that Alfred was a sinner and he had 5000 great victories but one sin and we can't have a road named after this man anymore. He says my personal opinion is I would not be in favor of naming a road after a person and I would encourage the Planning Commission to look to a different road name, like Barrow Road (it continues on across Route

35), I see that as appropriate or Millpond Road, I see that as appropriate; not after a man's name because the winds of change, five years from now we will probably be looking at this name change again and I just think we need to avoid those awkward situations.

Chairman Drake says thank you for your comments, any other comments.

Commissioner Turner says yes.

Chairman Drake recognizes Mr. Turner

Commissioner Turner says I agree with everyone here, I think the road name needs to change one way or the other so the answer to question one would be yes. He says the Board of Supervisors is looking for let's say a group of three names. He says Mrs. Lewis was saying Mr. Johnson was looking for.

Commissioner Edwards says changing the name is moot, that's gone.

Commissioner Turner says yes, he says do we want to give three options to the Board of Supervisors like Alfred Road, Millpond Road and continue Barrow Road or do we need to narrow it down to just one.

Commissioner Randall says I think we can do either, the Board is going to have all the information and probably more.

Mrs. Lewis says they will hold a public hearing as well.

Commissioner Drake says so Mrs. Lewis, looking for direction, do you think we need to give a series of names; would that be proper for us tonight.

Mrs. Lewis says that's what Mr. Johnson asked.

Chairman Drake says so we are not trying to limit it to one.

Mrs. Lewis says you need two motions, change name yes or no and the second motion with name recommendations.

Chairman Drake says, Mr. Mann I haven't heard from you. What do you think about changing the name of the road? He says do you have a comment.

Commissioner Mann says yes, I do, I was being polite letting Mrs. Lewis finish up. He says I would like to ask a question, I see on the summary, you've got Billy Cole against that, and I'm reading his letter and I guess I didn't see his letter before I got here tonight and I'm trying to figure out if he is against renaming is that what I'm gathering.

Mrs. Lewis says from my reading of the letter, he is against renaming the road because he feels it is doing away with history that needs to be remembered.

Commissioner Mann says that's what I gathered, so he is against renaming it to Alfred, he wants to leave it like it is. He says, I understand he is a big history buff.

Mrs. Lewis says her reading of it was he thinks that the historical name of Blackhead Sign Post Road honors what happened and changing the name would sanitize and not make that history.

Commissioner Mann says I agree that we need to change the name, he said I think I voted against the last time we were trying to do it but I wasn't voting against the name change, I agree with changing the name, I wanted to keep it generic. He says the history of the county is the history of the county, good, bad, ugly, whatever but I find that there are a lot of things that people find offensive and there was one suggestion to just put the road number back on the road sign 658 but I would rather send the Board three names and not just funnel it down to one.

Chairman Drake says it seems like there is a consensus on the Board that we need to change the name of the road, correct?

Commissioner Randall says I make a motion that we change the name of the road.

Chairman Drake says I have a motion that we change the name of the road, do I have a second.

Commissioner Mann say second.

Commissioner Edwards says were have already decided that, we don't have to vote on that, that's been decided by the Board.

Mrs. Lewis says no.

Chairman Drake says the decision that was made was to how the procedure would be with a changed road.

Mrs. Lewis says the ordinance that was adopted permitted the Board of Supervisors to initiate this request but the request still had to come to this body to change the name and the second, what it should change to.

Chairman Drake asks Commissioner Edwards if that answers his question.

Commissioner Edwards says not really, he says the fact that we have to change it, there is no argument about that but I think what the Board wants from the Planning Commission is a name or a list of names and so when we have our public hearing we could vote on the other two.

Chairman Drake says we have a motion and a second to that motion so I guess we are going to carry it forward if there are no objections. He says, is there any other discussion.

Chairman Drake calls for the vote to change the name of the road.

He says, all those in favor, say aye

Chairman Drake continues, any opposed, like sign.

He says it is a unanimous vote to change the name. He says, I have heard two or three suggestions is there any discussion.

Commissioner Mann says I have a question. Since you made this summary sheet, Mrs. Lewis, how many of these people that made a suggestion or have written in actually live on that road.

Mrs. Lewis says I believe Ms. Adkins lives on the road who suggested Big Pumpkin Road,

Chairman Drake says Mrs. Brandi Barnes lives on the road.

Commissioner Mann says doesn't Joseph Drake live on the road.

Chairman Drake says yes he does.

Mrs. Lewis says Ms. Toya Bynum says she is from Southampton County but she doesn't say that she lives on the road and Anna Carter grew up in Newsoms and maintains a home there but she doesn't indicate that she lives on the road but Mr. Joseph Drake lives on the road, Ms. Glass does not live on the road and Sarah Poole does not live on the road and Mr. Sunday does not and Ms. Triplett lives in Courtland.

Commissioner Mann says Billy Cole does not live on the road.

Mrs. Lewis says no.

Chairman Drake says but Mrs. Barnes.

Mrs. Barnes, Mr. Drake, Ms. Adkins all live on the road.

Chairman Drake says does that answer your question Commissioner Mann?

Commissioner Randall so we have no name, just the route number, Alfred Road which seems to be the consensus at least on the chart, Big Pumpkin Road had one recommendation and then Millpond Road.

Commissioner Edwards says that I heard before the road was changed, it was Millpond Road was the official name of the road.

Commissioner Mann says and Barrow, which is the crossroad.

Chairman Drake says living in Newsoms, being a resident, that resident has typically been referred to as Millpond Road

Commissioner Mann says yes, I can verify that.

Chairman Drakes says we have four suggestions for the Board of Supervisors, is there any more from this Board.

Commissioner Mann says actually have five, the one mentioned about Barrow Road extending across.

Mrs. Lewis says so what are the suggestions, Alfred Road, Millpond Road, Barrow Road and the road number 658.

Chairman Drake says can you do that, he says the road names were before the 9-1-1, that was the reason the roads were named, because of the 9-1-1 emergency system back in 1987. He says, I think that's why we are trying to do away with the road numbers and come up with a name.

Commissioner Mann says I'm just saying somebody mentioned it, do the number and write it out, six hundred and fifty-eight to keep it generic, the point was that if we get in to setting a precedence, we get into changing road names in the future, you can just write out the road number and move on, every time. He says, that was there suggestion, just use the road number and write it out.

Mrs. Lewis says, so that's four.

Chairman Drake says do we need to vote on that.

Commissioner Randall says I make the motion to recommend the names of Alfred Road, Millpond Road, says he doesn't see any reason to consider Barrow Road since it is confusing and will confuse our EMS, and quite frankly, I don't have a very good third name so I'll just go with Big Pumpkin Road because that was recommended by someone who lives on the road.

He says, so I've already expressed how I think you should have it but I'm not going to make that part of my motion.

Chairman Drake says we have a motion on the floor for Alfred Road, Big Pumpkin Road, and Millpond Road, that's the motion. He says, do I hear a second.

Commissioner Edwards says second.

Chairman Drake says, I have a second to the motion. He says is there any other discussion or comments, if not, I'm going to ask for the vote.

He says, all those in favor of this recommendation, say aye

Chairman Drake says any opposed.

Commissioner Chesson says Aye.

Chairman Drake says we have one opposed, so it carries as a recommendation to the Board at the January meeting.

Commissioner Chesson says please let it be noted that I didn't vote for the change of the road name.

Chairman Drake says certainly and I understand exactly where your mindset is.

Chairman Drake says we will now go to Item 4, unfinished business, discussion of review of 2015 Comprehensive Plan per GS 15-2-2230. Discussion.

Chairman Drake says we will start with our Comprehensive Plan Update on the Agriculture chapter. He says you know we talked about this last month and we have to continue on with the update of the Comprehensive Plan and I know Mrs. Lewis and her comment in our package, there are several questions, I hope you are have given some thought to those questions. He says I know it is a lot of blanks to fill in so is there any comments as we proceed with updating the agricultural chapter, anything need changing. He says there are a lot of reasons listed on the front page, is there anything in particular that stands out that we need to address or changing some statistical figures and re-issuing a new Comp Plan. He says is there any comments.

Chairman Drake says Commissioner Mann you may be able to allude to this, in some respects you might see the number of farms decrease, I know I would say that a lot of youth are coming back to the farm and that is very exciting for us old timers that family members and non-families of the children are coming back looking for a career in farming and agriculture. He says that is pretty exciting because I know it's been several cycles of times when agriculture didn't seem to be that exciting but I think with technological advances, the market growing especially the export market with the container and the ships coming, it's

### Southampton County Planning Commission Public Hearing - Thursday, December 10, 2020

My name is Michelle Covington, and I am a member of Citizens for Change and a resident of Boykins, Va.

First, I would like to commend you, the Planning Commission, as well as the Board of Supervisors on taking the bold first step in amending the original ordinance for renaming streets in Southampton County to include the option that would allow the Board of Supervisors to initiate the process. Because of that decision, we as a county are on our way to correcting a wrong that has stood as acceptable for far too long.

I, along with the other members of Citizens for Change, want to make it clear that while we are in favor of changing the name to something more appropriate, we are strongly against renaming it anything that ignores the reality of what occurred there. The tragic truth behind Blackhead Signpost Road is what it is. As a community, our task now is to find a balance between maintaining the history and addressing the blatant insensitivity that the current name displays.

Therefore, it is my recommendation that we rename Blackhead Signpost Road Alfred Road.

We have conducted extensive research on the events that led to Blackhead Signpost Road, and we can provide a list of the resources we consulted during our research process, if needed. The culmination of our research tells the story of an unfortunate enslaved man named Alfred, who was owned by Levi Waller at the time of Nat Turner's insurrection. Alfred was not an original member of Nat Turner's group. In fact, when Turner attacked the Waller School, located on current-day Barrow Road, Alfred tried to escape the mayhem. Levi Waller watched in fear from his hiding place in his garden as his wife, children, and several other school children were killed. The freedom fighters saw Alfred running away and ran after him, thinking that he was Levi Waller. This instance of mistaken identity saved Waller's life, giving him the opportunity to escape. When the fighters returned to take what they needed from the Waller School, Alfred came back with them, perhaps by force because Alfred soon deserted the freedom fighters when the opportunity presented itself. There is no research that implicates Alfred in any of the rebellion killings. According to "Nat Turner's Revolt: Rebellion & Response in Southampton County, Va" by Dr. Patrick Breen, Alfred did not remain with Nat Turner and his followers very long. He attempted to return home; however, he was caught by Alexander Peete and the Southampton militia. Unable to carry Alfred along in their pursuit of Nat Turner and his followers and understanding the value of slaves who could potentially survive trial, Peete decided to maim Alfred by cutting his Achilles tendons so that his fate could later be determined and so that he would be unable to reconvene with Turner. Levi Waller happened upon Alfred and attempted to bandage his legs--an action that further indicates Alfred's innocence--when the Greensville cavalry arrived. According to Levi Waller's petition for compensation for the property loss of Alfred, the Greensville cavalry leader, Dr. Scott, determined that the Southampton troops' actions were misguided and "deemed that [Alfred's] immediate execution would operate as a beneficial example to the other insurgents," so "after a severe reprimand to Waller, [Scott]

ordered that Alfred be tied to a tree and shot." Several secondary sources surmise that it was Alfred who was then decapitated and whose head was placed on display at the intersection of Blackhead Signpost Road and the New Jerusalem Road (now Meherrin Road). While there is no research from any primary source that definitively records Alfred or any other name of the person displayed on Blackhead Signpost Road, there is no question that at least one Black person was killed and his remains were placed on display as a horrific intimidation tactic at this intersection. We can reasonably conclude that Alfred was the *likely* victim because the path he would take to return to the Waller School fits the vicinity of Blackhead Signpost Road, because Dr. Scott of the Greensville cavalry insisted that he be made to serve as an example to other insurgents, and because in William Drewry's book, *The Southampton Insurrection*, there is a footnote which indicates that the person displayed at Blackhead Signpost Road was shot, rather than some other method of killing.

Through the connections of Mr. Rick Francis, we were able to receive the opinions of some of the historians whose research we have cited. In particular Dr. Patrick Breen, the author of the dissertation entitled "Nat Turner's Revolt: Rebellion & Response in Southampton County, Va.," admitted that while there is no recorded proof of what happened to Alfred's body after he was shot, Alfred certainly was one of the people who was summarily executed and could have been there. To quote Dr. Breen directly, he said "I would think that Alfred would be a fitting person to name the street after."

After Turner's insurrection, over 200 Blacks were murdered, some were guilty but most were innocent. While the insurrection and its victims are thoroughly documented, the subsequent victims of the backlash are not. This one-sided history has plagued our community long enough; it is time that we begin to bridge the gap between what one side was comfortable with recording and the whole truth. There is nowhere in the county where the lives of those innocent Blacks who were killed are recognized. The Blackhead Signpost Road sign is the only surviving evidence of the retribution, and it has been our goal since the beginning of this process to transform the lonely road sign from an offensive reminder to the appropriate memorial that it should be. To that end, we have raised the funds to also add a historical marker to properly annotate the history. The proposed text for the historical marker reads as follows:

In the days following Nat Turner's Insurrection of 1831, hundreds of enslaved, free, guilty, and innocent Blacks were killed in retaliation in Southampton and surrounding counties. At this intersection, a severed head was displayed and left to decay to intimidate and deter others from rising against slavery. It is likely that the beheaded man was Alfred, the slave of Levi Waller. Alfred was not implicated in Turner's Insurrection. This road became infamously known as Blackhead Signpost Road and is the only relic of the barbaric backlash that followed the insurrection. The road name was changed to Alfred Road in 2020.

This draft for the marker text was submitted along with the VA historical marker application last month and includes a notation explaining that the renaming process is not yet complete. Our application is scheduled for review at their June 2021 meeting. The name Alfred Road would

not only complement but also add to the significance of this historical marker, and just as visitors travel to view the Nat Turner historical marker near Cross Keys Road, which I hope to see replaced soon, this new road name and marker would also draw traffic to the area and would make a meaningful stop on the Nat Turner tours that people travel miles and pay to experience.

Right across the street is Barrow Road, named for Captain John Barrow who notably fought Turner and his followers valiantly in defense of his family. To name the adjacent street after Alfred would create an overdue juxtaposition that would help to add context that supports a more complete recount of Turner's Insurrection and the events that followed. History is complex and uncomfortable, but the more we work to reveal the whole truth and to appropriately represent history, especially the parts that are difficult, the better prepared our future generations will be to recognize and call out when society begins to head down a familiar wrong path. Unfortunately, most of the stories of the hundreds of murdered innocent Blacks who died in the backlash of the Insurrection are lost, but Alfred, we are sure, is strong enough to stand for them all.

Based on the research provided and the need to select a name that eliminates the insensitivity of the current name but not the history it represents, please consider recommending Alfred Road as the new name for Blackhead Signpost Road.

Before I take my seat, I'd like to submit a copy of my comments to be included in the documentation for this meeting as it will provide context for the many emailed requests for Alfred Road.

Hello Mike--

I am giving you this comment regarding the changing of the name of Blackhead Signpost Road as a Southampton County native and not as the man who headed the road-naming committee. I have thoughts about that as well as my connections to the community of Blackhead, but I will save them for another time.

Rather than erase the memory of the enslaved man whose life and death are commemorated by the name of this road and this incident by changing the historic name of the road, I think the county should in fact highlight the importance of this event considerably.

The black man, an enslaved man, while participating in what turned out to be a fruitless effort to achieve his freedom as well as the freedom of the other "insurgents" and the whole enslaved population of his neighborhood, Southampton County, Virginia, the South, and the nation lost his life in that bold effort.

This man was a martyr to the cause of freedom of slaves everywhere. He was not just a martyr who lost his life—he was a martyr who lost his life and his physical integrity and had his body disfigured in the most horrific way.

This man, whose name we perhaps know, joins the ranks of other martyrs, the most noted of whom are Joan of Arc, Nathan Hale, and John Brown, who were ordinary people and who sacrificed their lives, willingly or unwillingly, for what they thought was a greater good than themselves. And in those notable cases, as well as the case at Blackhead, history has proven them right.

We do not need to know his name for sure---he, likely Alfred, stands for all men and women who have given their lives in the fight for freedom, and our "Alfred" lost his life in the same way as hundreds of others before and after him.

His murderer and tormentors intended their actions to be a physical and very public humiliation to quell the rebellion, when, in fact, over time, their acts provided incentive and promotion of the exact opposite of their intent. Instead they actions became a piston in the unstoppable engine that ultimately freed all the slaves.

Why are we not honoring him and his ilk instead of wiping this incident from the map? Why are we not only retaining the historic name of the road but erecting a marker for generations to come to honor that man, to tell what happened here, and to inform the public how history was affected by this event?

I see the road's name as a metaphor for the fight for freedom and a monument to the struggle of named and unnamed enslaved and martyred men and women to be visited to learn that story.

The property is in the Capron Voting District and the Berlin-Ivor Magisterial District;
- 3. An application by Charles and Debi Darden, applicants, on behalf of Charles, Debi, and Michael Darden, etals, owners, for a Conditional Use Permit to operate an event venue, per Sec. 18-37 (40) of the Southampton County Code. The property is known as a five (5) acre portion of Tax Parcel 106-19D, which totals 27.53 acres. The property is located on the east side of Smiths Ferry Road (US 258) approximately 2,300' south of its intersection with Schoolhouse Road (SR 689).
