## **RESOLUTION #2-2019**

A RESOLUTION TO ESTABLISH FEES FOR CAMPGROUNDS AND TEMPORARY CAMPGROUNDS IN ACCORDANCE WITH 3729.07 OF THE OHIO REVISED CODE AND 3701-26-03(I) and (J) OF THE OHIO ADMINISTRATIVE CODE.

WHEREAS, Ohio Revised Code (ORC) section 3729.07 allows for the establishment of fees in accordance with ORC section 3709.09 for the purpose of administering and enforcing the requirements of ORC 3729 and the rules adopted thereunder; and

WHEREAS Ohio Administrative Code (OAC) 3701-26-03 (I) and (J) establishes fee categories for campgrounds with fifty or fewer sites, campgrounds with greater than fifty sites, and temporary campgrounds; and

WHEREAS, OAC 3701-36-14(A) requires that cost methodology specified in OAC 3701-36 be utilized to calculate fees for services provided in ORC Section 3729.07 and the Board of Health having calculated those fees has determined that fees should be increased; and

WHEREAS, industry representatives have expressed concern about the increase to the temporary campground fee, and have requested a step-wise increase.

BE IT THEREFORE RESOLVED, by the Board of Health of the Stark County Combined General Health District, that the licensing fee for each campground and temporary campground be as follows:
